**Subject:** Clarification with regard to the faculty for B.Ed. and D.El.Ed. programmes of one unit as per the NCTE Regulations, 2014 and submission of faculty list in reply to Letter of Intent where list has already been submitted by the institution – reg.

Sir,

I am directed to refer to your letter F.No.NRC/U.P.-I/8/2014/80266 dated 7<sup>th</sup> January, 2015 followed by an email dated 19.01.2015 on the subject mentioned above and to say that the issues raised in your letter and email under reference regarding submission of faculty list in reply to Letter of Intent in case where the list has already been submitted by the institution and related matter have been examined in NCTE. The Competent Authority in NCTE has decided to communicate the following clarifications enabling RCs to further process the pending applications.

Sl. No.	Clarification sought by the NRC	Clarification given by NCTE Hqrs.
1	Submission of faculty list in reply to Letter of Intent in cases where the list has already been submitted by the institution	The institutions which have submitted reply to the 7(9) issued by Regional Committees may be issued formal recognition orders, if otherwise fulfilling all other conditions for grant of recognition, with the direction that they shall ensure compliance of the faculty as per Regulations, 2014, wherever necessary, before commencement of the academic session 2015-16. The modification/replacement required in the faculty list shall be pointed out and the institution shall be required to submit the compliance report before the commencement of the session.
2	The faculty in respect of B.Ed. & D.El.Ed. courses for one unit as per the provisions of the NCTE Regulations, 2014	The Regulations, 2014 permit/allow an institution to take two units at a time of a teacher education programme, accordingly, the faculty requirements have been laid down for two units of the programme in the Regulations 2014 that is for 200 students in the first and the second years. However, if the existing institutions and those institutions whose applications are pending opt for one unit, that is 100 students for the programme, the requirement of faculty shall be reduced to eight out of which five lecturers i.e. one each for



		Science, Social Studies, Mathematics and two for Languages and one Health and Physical Education lecturer and one Performing/Visual Art, and one Principal or Head of the Department shall be engaged. One of the lecturers may possess postgraduation degree in Psychology/Philosophy/Sociology if the Principal/Head of the Department possesses PG degree in one of the school subjects.
3	As the Regulations, 2014 provides for recognition in composite institution, how the applications pending in the NRC will be processed further?	The institutions whose applications were pending with the Regional offices before 01.12.2014 (the date of notification of Regulations 2014), shall be considered for recognition as stand alone institutions but while issuing formal order, there shall be a condition in the order that they shall move gradually to become a composite institution but not later than 2016-17.

In view of the above clarifications, you are advised to process the pending applications. It may be ensured that the institutions whose applications are pending may be disposed of by the cut-off date stipulated in the order of the Hon'ble Supreme Court, that is, 3<sup>rd</sup> March, 2015.
