
This is to bring to your notice that UG has notified UGC Regulations on curbing the menace of ragging in Higher Education institutions, 2009. These Regulations have been notified on 17.6.2009 in the Extra Ordinary Gazette of India. A copy of the same is enclosed with this letter for ready reference.

The UGC has been conducting meetings and taking stock of the progress in the matter from different stakeholders. NCTE is one of the organization which is expected to report to UGC for progress in the matter. In this connection, a meeting was convened by the UGC on 26.5.2016 which was attended by the Member Secretary besides other members of other organizations. Under Item No. 2 of the agenda it was noted that all the Councils were advised for compliance of UGC letters dated 11.06.2014 and 01.05.2015.

In this connection, it is requested that all the teacher education institutions recognized by NCTE in your region should be informed through a communication about the provisions contained in the UGC Regulations and compliance of that shall be made by each and every institution in spirit and words. An action taken report may please be forwarded to this office for onward transmission to UGC as compliance.
