Sir/Madam,

This has reference to the subject cited above, institution has submitted an application in online mode on 30.09.2011 and physical application has been received in the office of NRC on 29.09.2011 for D.EL.ED. course in the proposed institution i.e. Om Sai Institution of Education, Plot No.- 728, 729, 730, Street- Delhi Road, Village- Pali, Post Office- Baghpat, Tehsil- Baghpat, Town/City- Baghpat, District- Baghpat, Pin Code- 250609, State- UP. The said application was processed by the NRC, NCTE as per provisions contained in the NCTE Regulation 2009. It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulation, 2009, your application was found deficient on the following points which are as under:-

- The institution has not submitted approved building plan in original. The original approved building plan approved by the competent authority indicating name of Institution, name of course, Khasra No./Plot No. of land, total land & total built up area for the course applied for, size of multipurpose hall and class rooms etc for the proposed course is required to be submitted.
- The building plan submitted by institution have plot/khasra no. as 728, 729, 730, 726 whereas in application form it is mention as 728, 729, 730 hence they are different.
- Copy of change of land use certificate issued under clause 143 of UP land Act by the competent authority has not notarized.
- The affidavit submitted by institution have plot/khasra no. as 730 whereas in application form it is mention as 728, 729, 730 hence they are different.
- The affidavit submitted by institution is not notarized.

The above deficiencies were communicated to your Institution by NRC vide letter No. NRCAPP-2570/D.El.Ed./UP/DLI/2012-13/19597 dated 12.04.2012 and the matter was considered by NRC in its 205th Meeting and as per decision taken by NRC, the application of the institution was closed vide latter dated 18.10.2012. The institution preferred an appeal dated 15.01.2013 to the NCTE, New Delhi under Section 18 of the NCTE Act, 1993 against the aforesaid order. In compliance of the order passed by the Appellate Authority (NCTE New Delhi), the matter was considered by NRC in its 211th Meeting and it was decided that deficiency letter may be issued again to the Institution.

2. In terms of above decision, the above deficiencies are hereby again communicated to you with advise to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
3. In addition to above, the institution is also requested to submitted original file FDRs of 5 lakhs & 3 lakhs which were return to the institution earlier.

4. Your reply/representation along with all necessary documents accompanied with an Affidavit in support of the reply of the above points must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Rules & Regulations.

5. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
