The Society/Trust has submitted an application through online mode on 19/12/2012 and physical application has been received in the office of NRC on 27/12/2012 for B.Ed course in the proposed institution, Umrao Bodh Mahavidhyala, Plot/Khasara No- 958, 1278/2, Vill- Shakti Nagar, Post Office- Meerut, Tehsil- Meerut, Distt- Meerut, Pin Code-250002, UP. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- i. Originally notarized change of land use (CLU) certificate issued by SDM under Section 143 of the U.P. Land Act is to be submitted.
- ii. The address of the Trust in the Trust Deed does not match with the application.
- iii. Certified copy of land documents (sale deed) registered by Registrar/Sub-Registrar not submitted. The institution has submitted only correction deed which also does not indicate anywhere the plot/khasara numbers.
- iv. The institution's address in the affidavit does not match with the application.
- v. FDRs of Rs. 5 lakhs towards endowment fund and 3 lakhs towards reserve fund in original of the nationalized bank not submitted.
- vi. Date of registration of the land and details of the office of Registrar in s.no.2 of the Affidavit not given.
- vii. Information at s.no. 5 in the affidavit is not filled-up. i.e. the no. & date of CLU certificate to be mentioned.
- viii. Building plan submitted is not approved by competent authority.
- ix. The address in the building plan does not match with the application.
- x. The Built-up area in the building plan does not match with the application.
- xi. The building plan does not mention for which course the building has been constructed.
- xii. There is over-writing in the plot/khasara nos. in the building plan.
- xiii. The building plan duly approved by the competent authority removing the above deficiencies be submitted.
- xiv. Minority certificate from the competent authority not submitted.
- xv. The title of the land not clear from s.no.3 of the Affidavit.
- xvi. The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.

2. You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

3. Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules &


