This has reference to the subject cited above, institution has submitted an application in online mode on 27.12.2012 and physical application has been received in the office of NRC on 03.01.2013 for B.Ed.(Additional intake) (Co.Ed.) Course in the proposed institution i.e. Vedant Institute of Education, Plot No.- 234, Village- Allahbhakshpur, Post Office- Salar pur, Tehsil/Taluka- Garhmukteshwer, Dist.- Ghaziabad, Uttar Pradesh- 245205.

2. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulation 2009. It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulation, 2009, your application is found deficient on the following points which are as under:-

- Plot no. / Khasra no. not mentioned in Building plan.
- The institution is situated of plot no. 234 in the application form whereas the institution has submitted CLU for plot no. 232.
- Earmarked area and built up area for existing and proposed course not shown in the building plan.
- The institution is already conducting B.Ed. (200 intake) , B.P.Ed (100 intake). Therefore this application is not permissible to submit the application under clause 8(3) of NCTE Regulations.
- Institution has also submitted another application APP 4656 for B.Ed. course. This is not permissible under clause 8.2 of Regulations 2009.
- Institution has submitted NAAC certificate with C. Grade. It is not permissible under clause 8(4) of NCTE Regulations 2009.
- The information at S. No. 5 of the Affidavit 100/- is not filled up properly.
- The institution is running B.Ed. course science 01.07.2004 whereas the institution has mentioned in on line application for new recognized.
- The institution is required to submit an Affidavit of Rs.100/- stamp paper as per the format enclosed in support of information required as per clause 8(2), 8(3) and 8(7)(ii) of the NCTE Regulations 2009 & page 4 & 5 of the Online Application form.


3. You are advised to remove/make well of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

4. Your reply/representation along with all necessary documents accompanied with an Affidavit in support of the reply of the above points must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Rules & Regulations.

5. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever is the case.
