The Society/Trust has submitted an application through online mode on 19/12/2012 and physical application has been received in the office of NRC on 31/12/12 for B.ED course in the PT Chandrika Smarak Purvanchal Mahavidhyalay, Plot/Khasara No36, 212, 48, 41, Plot No. - 36,212,48,41, Street Number- NA, Vill- Tipakkabad, Post Office- Mohamdabad Gohna, Teh/Taluk- Mohamdabad Gohna, Town/City- Mohamdabad Gohna, Dist- Mau, State-UP, Pin-276403. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations 2009, your application is found deficient on the following points which are as under:-

1. Originally notarized change of land use (CLU) certificate issued by SDM under section 143 of U.P. Land Act not submitted. Certificate submitted is un-notarized and in respect of plot nos. 38,212,48,41 do not match with the application.
2. The plot nos. given in the application do not match with the land documents.
3. Certified copy of registred land documents in respect of plot no.41 not submitted.
4. The land area in the application does not match with the land documents.
5. The name of the village in the building plan and land documents does not match with the application.
6. The building plan has not been approved by the competent authority.
7. The address of the trust does not match with the application.
8. Memorandum showing names of office bearers with designation of the trust not submitted.
9. The institution is also required to submit an Affidavit on Rs 100/- stamp paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of NCTE Regulations,2009 and Page 2,4 and 5 of the online application form.

2. You are advised to remove /make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

3. Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

4. Reply in piecemeal will not be accepted. Since application has been processed as per clause 6 of NCTE Regulations, 2009, hence, once the application is duly processed by this office, the claim for refund of application /processing fee cannot be made at any stage of application, whatsoever be the case.

5. Please mention the code number of your application in all your future correspondence.

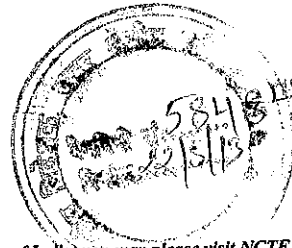
