
Sir/Madam,

The Society/Trust has submitted an application through online mode on 23/12/2012 and physical application has been received in the office of NRC on 27/12/2012 for B.Ed. course in the proposed institution, by Prakash Mahavidhyalay Pac Road Etah, Plot No. 625, Khasara NO. 625, Street Number- NA, Village/Town- Sirawn, Post office- Etah, Tehsil/Taluka- Etah, Town/City- Etah, State- UP, District- Etah (UP), Pin Code -207001. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- i. CLU submitted is not originally notarized. Originally notarized change of land use (CLU) certificate issued by SDM under Section 143 of the U.P. Land Act is to be submitted.
- ii. Information in the affidavit at s.no. 2 not furnished properly i.e. total Plot area, date of registration and office of registration not mentioned.
- iii. The Affidavit submitted by the institution is not signed by the applicant.
- iv. FDRs submitted are not of the Nationalized Bank. FDRs of Rs. 5 lakhs towards endowment fund and 3 lakhs towards reserve fund in original of the nationalized bank is to be submitted. The FDRs submitted are returned herewith.
- v. The name of the institution in the FDRs does not match with the application.
- vi. The CLU submitted is dated 24/12/2012 which date is after the date of online submission of the application.
- vii. The Land is in the name of Shri Prakash Mahavidyalay, whereas the name of the institution as per application is Prakash Mahavidyalaya.
- viii. Name & address of the institution in the building plan does not match with the application.
- ix. Name of the course not mentioned in the building Plan.
- x. Name of the institution in the Affidavit does not match with the application.
- x. Title of the Land not mentioned clearly in s.no. 3 of the Affidavit.
- x. The address of the society in the registration certificate does not match with the application.
- x. The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.

You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

3. Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.
4. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/ processing fee cannot be made at any stage of application, whatsoever be the case.
