The Society/Trust has submitted an application through online mode on 21/12/2012 and physical application has been received in the office of NRC on 28/12/2012 for D.El.Ed. course in the proposed institution, by Neta Ji Vijay Bahadur Yadav Pratikshan College, Plot No. 94,605,608,611,613,620, Khasara NO. 94,605,608,611,613,620,, Street Number-NA, Village/Town- Dandikalan, Post office- Ruhipur, Tehsil/Taluka- Ghazipur, Town/City- Ghazipur, State- UP, District- Ghazipur (UP), Pin Code -233308. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- i. Certified copy of registered land documents issued by the Registrar/Sub-registrar to be submitted. The institution has submitted only Khotoni.
  - ii. Originally notarized change of land use (CLU) certificate issued by SDM under section 143 of U.P. Land Act not submitted.
  - iii. The building plan submitted by the institution is only for plot no. 94, whereas in the application the institution has mentioned the plot nos. 94,605,608,611,613,620.
  - iv. The building plan does not show for which teacher education course the building has been constructed.
  - v. The Address of the institution given in the building plan FDRs does not match with the application.
  - vi. The Total land area not mentioned in the building plan.
  - vii. It is not clear from the file that the plot/Khasara no. 94,605,608,611,613 and 620 as mentioned in the application are adjacent to each other or not. The document from the competent authority in support of this be submitted.
  - viii. The address of the society given in the registration certificate and by-laws does not match with the application.
  - ix. The Khasara no. given in the affidavit does not match with the application.
  - x. The address of the society in the affidavit does not match with the application.
  - xi. The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.
2. You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
3. Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.
4. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
