Sir/Madam,

The Society/Trust has submitted an application through online mode, on 28/12/2012 and physical application has been received in the office of NRC on 02/01/2013 for D.El.Ed. course in the proposed institution, Shri Radha Krishan Educational Institute, Plot/Khasara No- 271, 275, Vill- 100 Futa Road Kalpna Kunj, Post Office- Shahganj, Tehsil- Sadar, Distt- Agra, Pin Code-282010, UP. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- i. Originally notarized change of land use (CLU) certificate issued by SDM under Section 143 of the U.P. Land Act not submitted.
  - ii. The name & address of the society in the society registration certificate & land documents does not match with the application.
  - iii. Fixed deposit receipts of Rs. Five lakhs and Rs. Three lakhs towards Endowment and Reserve Fund in original from Gramin Bank submitted and not from Nationalized Bank. The FDRs are returned herewith.
  - iv. Dates of registration of land in the affidavit not filled up.
  - v. The title of the land not mentioned clearly in s.no.3 of the Affidavit.
  - vi. Total plot area in the application does not match with the application.
  - vii. Plot/khasara nos. not mentioned in the building plan.
  - viii. The address of institution in the building plan does not match with the application.
  - ix. The building plan has been approved by Pradhan, Dehtora, whereas the proposed building is in village Katyan Kunj.
  - x. Document from the competent authority indicating that the plot/khasara nos. 271 and 275 are adjacent to each other to be submitted.
  - xi. Land area in the application does not match with the land document.
  - xii. Name of the institution in the building plan does not match with the application.
  - xiii. The land area in the building plan does not match with the application and is also less as per norms for the course.
- Built-up area in the building plan does not match with the application.  
Name of Village Dehtora does not appear in the address of the institution in the application.  
The objectives of the society and list of office bearers not submitted.  
The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.


2. You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

4. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/ processing fee cannot be made at any stage of application, whatsoever be the case.
