This has reference to the subject cited above, institution has submitted an application in online mode on 28.12.2012 and physical application has been received in the office of NRC on 03.01.2013 for D.El.Ed (Co.Ed) Course in the proposed institution i.e Pt Kripashankar Shishan Prashishan Mahavidyalay, Plot No.- 2312,2112,258k,2298k, Village – Pethiya, Post Office – Pethiya, Tehsil– Jalalpr, Dist.– Ambedkar Nagar, State– Uttar Pradesh – 224149.

2. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations 2009. It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- As per online application form institution is located at Plot no. 2312, 2112, 258k, 261k, 2298k. Whereas land document for land at Plot no. 2298d, 2112, 2312 and Plot no. 2189, 227 is submitted. Total land area for plot no. 2298d, 2112, 2312 is of 2310 Sq. Mts. which is less than 2500 Sq. Mts. as per required under clause (5)(i)(a) of appendix 2 of NCTE Regulations 2009.
- FDR for Rs 5.00 lacs of Nationalized bank towards Endowment funds in original is required.
- FDR for Rs 3.00 lacs of Nationalized bank towards reserved fund in original is required.
- Legible notarized copy of change of land use (CLU) certificate issued by SDM under section 143 of UP Land Act is required.
- The institution is required to submit an Affidavit of Rs. 100/- stamp paper as per the format enclosed in support of information required as per clause 8(2), 8(3) and 8(7)(ii) of the NCTE Regulations 2009 & page 4 & 5 of the Online Application form.

3. You are advised to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

4. Your reply/representation along with all necessary documents accompanied with an Affidavit in support of the reply of the above points must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Rules & Regulations.

5. Reply in piecemeal will not be accepted. Since application has been processed as per clause 6 of Regulations 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
