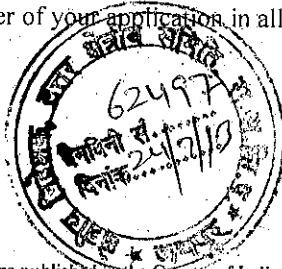


Sir/Madam,

The Society/Trust has submitted an application through online mode on 31/12/2012 and physical application has been received in the office of NRC on 04/01/2013 for B.Ed. course in the proposed institution, by Sri Chitragupta P G College, Plot No.00000000000, Khasara No. 00000000000, Street Number- 00000000000, Village/Town- Chauthiyana, Post office- Mainpuri, Tehsil/Taluka- Mainpuri, Town/City- Mainpuri, State- UP, District- Mainpuri (UP), Pin Code - 205001. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- i. Copy of Registration, Memorandum, By-laws and objectives of the society / trust not submitted.
 - ii. Originally notarized change of land use (CLU) certificate issued by SDM under Section 143 of the U.P. Land Act not submitted.
 - iii. No plot/khasara no. mentioned in the application and Land documents.
 - iv. The information at s.no.5 of the Affidavit not filled up i.e. the no. and date of CLU is to be mentioned.
 - v. The name of the institution in the land document does not match with the application.
 - vi. From the land document wherein land has been sold by Smt. Usha & Nisha, the area of land out of 10492 Sq.ft. is not clear, Hence, clarification be given
 - vii. The land area is less as per norms for the course.
 - viii. All dates of registration of land documents not mentioned in the Affidavit.
 - ix. Title of the land not mentioned clearly in s.no. 3 of the affidavit.
 - x. As per application, the institution is also running B.A., B.Sc., B.Com., M.A. and M.Sc. courses. Clarification be given whether these courses are being run in the same building in which the B.Ed. course has been proposed or at a different location. If at a different location, the complete address details be given.
 - xi. The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.
2. You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
 3. Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.
 4. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/ processing fee cannot be made at any stage of application, whatsoever be the case.
 5. Please mention the code number of your application in all your future correspondence.
