- Certified copy of registered land documents issued by the competent authority (Office of Registrar/ Sub Registrar) as required under provision of NCTE Regulations, 2009 has not submitted.*
- A Copy of approved Building plan having demarcated built-up area for proposed B.Ed. course, existing course, and other educational courses being conducted by institution at khasra no. 1/1 ऋ is required to be submitted.*
- A Copy of site plan having demarcated land area for proposed B.Ed. course, existing course, and other educational courses being conducted by institution at khasra no. 1/1 ऋ is required to be submitted.*
- A copy of Registration Certification of Society/Trust is not submitted.*
- The institution is required to submit an Affidavit of Rs.100/- stamp paper as per the format enclosed in support of information required as per clause 8(2), 8(3) and 8(7)(ii) of the NCTE Regulations 2009 & page 4 & 5 of the Online Application form.*

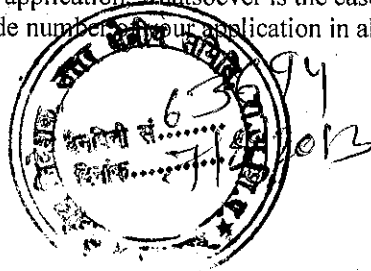
3. You are advised to remove/make well of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

4. Your reply/representation along with all necessary documents accompanied with an Affidavit in support of the reply of the above points must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Rules & Regulations.

5. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever is the case.
