This has reference to the subject cited above, institution has submitted an application in online mode on 28.12.2012 and physical application has been received in the office of NRC on 02.01.2013 for B.Ed.(Girls) course in the proposed institution i.e Peoples Action Teachers Training Institute, Plot Number - 506, 507/1574, Village - Keshavpur Paharwa, Post Office - Keshavpur Paharwa, Tehsil/Taluka - Gonda, Dist. - Gonda, UP- 271001.

2. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulation 2009. It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulation, 2009, your application is found deficient on the following points which are as under:-

1. Originally notarized change of land use (CLU) certificate issued by SDM under section 143 of UP Land Act not submitted.
2. Plot no. 507/1574 mentioned on online application form, affidavit, land document does not match plot no. 507 mentioned in the building plan.
3. The institution is required to submit an Affidavit of Rs. 100/- stamp paper as per the format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (ii) of the NCTE Regulations, 2009 & page 4 & 5 of the Online Application form.

3. You are advised to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

4. Your reply/representation along with all necessary documents accompanied with an Affidavit in support of the reply of the above points must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Rules & Regulations.

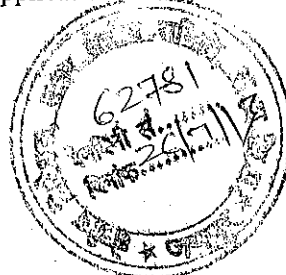
