The Society/Trust has submitted an application through online mode on 28/12/2012 and physical application has been received in the office of NRC on 04/01/2013 for M.Ed. course in the proposed institution, by Oxford College of Education, Plot No. NA., Khasara No. 65/9/2/2, 12/1/1, 20/2., Street Number- NA, Vill.- Khera Khurrampur, Po. off- Farrukh Nagar, Tehsil- Farrukh Nagar, Town- Farrukh Nagar, State- HR, District- Gurgaon(HR), Pin Code -123506. The said application has been processed by the NRC, NCTE as per contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- i. Originally notarized change of land use (CLU) certificate issued by the Competent Authority not submitted.
- ii. Blue print of the building plan duly approved by the competent authority indicating the name & address of the institution, total land area & built up area for the existing and proposed course, name of the course to be submitted.
- iii. Plot/khasara nos. and Land area given in the Land documents does not match with the application.
- iv. The address of the Trust given in the Land documents, FDRs and Trust deed does not match with the application.
- v. Affidavit in the prescribed format on Rs.100/- stamp paper duly attested by oath commissioner or Notary Public as required under provision of clause 7 (1) of NCTE, Regulations, 2009 not submitted.
- vi. Khasara no. given in the Affidavit does not match with the application.
- vii. Affiliating body not mentioned by the institution in the online application.
- viii. The details of FDRs submitted for B.Ed. course submitted, i.e. date of issue name of bank, FDR nos., whether in individual name or joint name.
- ix. The institution is also running B.Ed. course. Clarification be given whether this course is run being in the same building in which the present application has been made or at a different location. If at a different location, the complete address details be given.
- x. The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page- 2, 4 and 5 of the online Application form.


2. You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

3. Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

4. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/ processing fee cannot be made at any stage of application, whatsoever be the case.
