



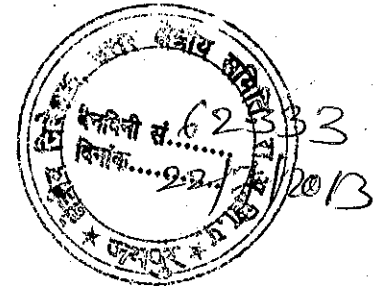

Sir/Madam,

The Society/Trust has submitted an application through online mode on 22/12/2012 and physical application has been received in the office of NRC on 24/12/2012 for increase in intake in B.Ed course in the existing institution, Translam College of Education, Plot/Khasara No- 385M, 386/2, 387M, 409/3, 405/2, Vill- Salarpur Jalalpur, Post Office- Rajpura, Tehsil- Meerut, Distt- Meerut, Pin Code-250001, UP. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- i. The address of the society in the registration certificate does not match with the application.
- ii. The society is running B.Ed. course. The complete address details of this course be submitted. i.e. whether the course is being run in the same building or separate land & building.
- iii. The total land area not mentioned in the building plan.
- iv. Building plan does not show for which teacher education course the building has been constructed.
- v. It is not clear from the file that the plot/Khasara no. 385M, 386/2, 387M, 409/3, 405/2 as mentioned in the application are adjacent to each other or not. The document from the competent authority in support of this be submitted.
- vi. The institution is also running BBA, BCA and other Programmes. Clarification be given whether these programmes are being run in the same building where the B.Ed. (additional intake) has been applied or on separate land and building.
- vii. Khasara nos. in the Affidavit, Building plan do not match with the application.
- viii. Land area in the application does not match with the land documents.
- ix. Originally notarized change of land use (CLU) certificate issued by SDM under Section 143 of the U.P. Land Act not submitted.
- x. From the land documents, it is observed that the land in r/o K.Nos. 385M, 386/2M, 387M is in the name of the "Electra Trust" and not in the name of the society/institution as per application. Certified copy of the registered land document in respect of these plot nos. in the name of the society/institution is to be submitted.
- xi. The institution has submitted Rent Agreement between the society and the institution for 30 years which is not valid as per NCTE Regulations, 2009. The society shall be required to transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of issue of formal recognition order.
- xii. The validity of building plan has expired. Renewed building plan indicating complete name & address of the institution, name of the course, total plot area, built-up area for the existing B.Ed. and proposed additional intake be submitted.
- xiii. The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.

2. You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
3. Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.
4. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/ processing fee cannot be made at any stage of application, whatsoever be the case.
