The Society/Trust has submitted an application through online mode on 22/12/2012 and physical application has been received in the office of NRC on 24/01/2013 for B.Ed. course in the proposed institution, by Brajraj Sahodra Mahavidyalaya, Plot No. 652, Khasara NO. 652, Street Number-1, Village/Town- Punnpur Pure Pahar Singh, Post office- Vishesharganj, Tehsil/Taluka- Amethi, Town/City- Amethi, State- UP, District- Sultanpur(UP), Pin Code -227120. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

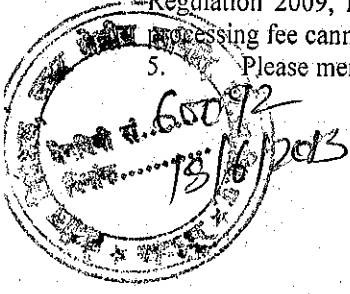
- i. The total land area in the CLU certificate does not match with the application.
- ii. The no. of FDRs for Rs. 3 lakhs does not match with the application.
- iii. The building plan does not show for which course the building has been constructed.
- iv. Plot no. given in the CLU does not match with the plot no. given in the application.
- v. Address of the society given in the registration certificate and By-laws does not match with the application.
- vi. As per Land document, the land is in the name of Baba Ram Baksh vidyamindir, whereas, the name in application is Brajraj Sahodra Mahavidyalaya.
- vii. The land area in the Land document does not match with the application and affidavit.
- viii. Khasara no. in the Affidavit does not match with the application.
- ix. The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.

2. You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

3. Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

4. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
