The Society/Trust has submitted an application through online mode on 11/12/2012 and physical application has been received in the office of NRC on 13/12/2012 for D.El.Ed. course in the proposed institution, Krishna Sudama Sansthan, Plot/Khasara No- 781, 785, Vill- Bhandaha Kala, Post Office- Kaithi, Tehsil- Sadar, Distt- Varanasi, Pin Code-221116, UP. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- i. Originally notarized change of land use (CLU) certificate issued by SDM under Section 143 of the U.P. Land Act not submitted.
 - ii. Information at S.No. 5 of the Affidavit not given i.e. the No. and date of CLU.
 - iii. Land document submitted is not certified by Competent Authority. Certified copy of land documents registered by Registrar/Sub-Registrar is to be submitted.
 - iv. The memorandum showing names of office bearers with designation of the Trust not submitted.
 - v. The address of the Trust in the Instrument of Trust does not match with the address given in the application.
 - vi. The Society Kedar Vijay Uchch Shiksha Sansthan has submitted application (NRCAPP2831) for B.Ed. course in the name of Krishna Sudama Sansthan on Plot Nos. 773, 781, 785, 786, Bhandaha Kala Kaithi, Varanasi, U.P. and the Society/Trust Krishna Sudama Sansthan has also applied for D.El.Ed. course (NRCAPP2936) on Plot Nos. 781, 785. The Plot Nos 781 and 785 are in both the applications. Hence, Clarification be given.
2. The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.
3. You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
4. Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.
5. Reply in piecemeal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
