Sir/Madam,

In terms of section 14/15 of the NCE Act, 1993 your Institution had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course in the proposed institution i.e. School of Education Galgotias University UP, Plot/Khasra Number- 2, Street Number- Sector-17 A, Village- Yamuna Expressway, Post Office-Greater Noida, Tehsil/Taluka- Noida, Town/City- Greater Noida, District- Gautam Buddha Nagar(UP), State- Uttar Pradesh, Pin Code- 203201.

- The NRC, NCTE on the basis of the scrutiny of the documents submitted by the institution, input received from the Visiting Team Report and videography in its 222nd meeting held on 24th to 28th December, 2013 decided that the above institution has adequate financial resources, accommodation, library and laboratory as prescribed in the norms and standards and institution for a teacher education course. Therefore, the NRC, decided to issue letter of intent prior to grant of recognition for B.Ed. course under clause 7(9) of the NCTE Regulation to the institution.
- 3. As per provision of clause 7(9) of NCTE Regulations, 2009. The process of appointment of qualified staff as per policy of State Government or University Grant Commission or University may be initiated by the institution and affiliating body will provided all assistance to the institution to ensure that the staff of faculty is appointed as per National Council for Teacher Education norms within two months. The institution shall submit the list of faculty, as approved by the affiliating body, to the Regional Committee.
- In this regard as per decision taken by NRC in its 199th meeting it is clarified that the above implies that where there exists a provision of nomination of experts for the Selection Committee by the affiliating university the same be adhered to. In the absence of such a provision in the Act/Statutes of the affiliating university, the institution shall select faculty members by emiversity. This approved list, along with details of educational qualifications and teaching experience, shall be submitted by the institution to the Regional Committee.
- Before grant of formal recognition under Regulation 7(11) of NCTE Regulation 2009 is considered, the institution shall make appointment of qualified faculty/staff as per provisions of the NCTE Regulations, 2009 as per the norms & standards envisaged therein and submit the following documents:-

. The institution shall submit particulars of the staff duly approved by the University/affiliating body as per the prescribed format available in the NRC, NCTE website.

b. Advertisement in leading newspapers.

Letter of University/ Affiliating Body, nominating experts/representative for the Selection Committee.

Recommendations of the Selection Committee for appointment of teaching & non-teaching staff as per the norms of the affiliating body.

e. An affidavit on Rs. 100/-stamp paper to the effect that the institution has selected staff as per NCTE sate University norms. (format Enclosed).

The compliance report/reply alongwith all necessary documents accompanied with an Affidavit in support of the reply of the above points should be submitted within two months of issue of this letter, failing which appropriate action will be taken as deemed fit and proper.
