Refusal Order

WHEREAS, in terms of section 14(1) of the NCTE Act, 1993 Lala Jagat Naryan Education Society, Plot No.- 226., Street/Road-Muktsar Road, Village/Town/City-Chak Arian Wala, Post Office-Jalalabad West, Tehsil/Taluka-Jalalabad West, Town/City-Jalalabad West, District-Firozpur-152024, Punjab had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Lala Jagat Naryan Education College, Plot/Khasra No-226,228, Street No.- Muktsar Road, Village-Chak Arian Wala, Post Office-Jalalabad West, Town/City-Jalalabad West, Tehsil/Taluka-Jalalabad West, District-Firozpur-152024, Punjab for M.Ed. Course in the office of NRC on 05.10.2011.

AND WHEREAS, as per decision taken by NRC, Deficiency letter dated 22.03.2012 was issued to institution on the following points:

- Certified copy of registered land documents issued by the competent authority is in regional language. The institution is required to submit the notarized copy of English translation of the land documents.
- Notarized copy of Change of land used Certificate issued by the competent authority may be submitted.
- The building completion Certificate approved by the competent authority in the prescribed format has not been submitted.
- The certificate of NAAC as required in the section 8 (4) of the NCTE Regulation, 2009 is not attached.
- Exclusively earmarked area for M.Ed. Course as per of NCTE regulation, 2009 be indicated in the map.

AND WHEREAS, the reply was considered by the NRC in its 206th meeting held from 17th to 19th October, 2012 and it was decided that VT be constituted to verify the infrastructure & Instructional facilities created by the Institution for M.Ed. Course as per the provisions of NCTE Regulation, 2009 for further processing of the application. The inspection of the institution was conducted u/s 14 on 28.12.2012

AND WHEREAS, the VTR was considered by the NRC in its 210th meeting held from 28th to 29th January, 2013 and NRC decided to issue letter of intent under clause 7(9) to the institution. Accordingly, a letter of intent under clause 7(9) was issued to the institution on 01.03.2013.

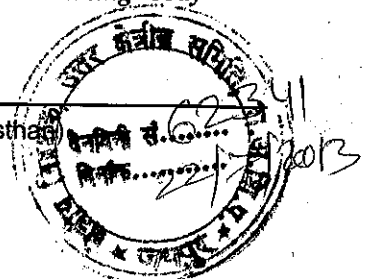
AND WHEREAS, the reply was considered by the NRC in its 214th meeting held from 24th to 25th April, 2013 and the NRC decided to issue show cause notice to the institution under section 14/15 of the NCTE Act 1993. Accordingly, show cause notice was issued to the institution on 18.05.2013 on the following points:-

- List of faculty submitted by the institution is not approved by the affiliating university.

AND WHEREAS the reply was considered by NRC in its 216th meeting held from 27th to 28th June, 2013 and NRC decided that the application for the said course be refused under provision of NCTE, Regulations, 2009 on the followings:-

The original file of the Institution and reply of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC in detail and following observations was made:-

- The institution has not submitted list of faculty duly approved by affiliating/examining body as required under clause 7 (9) of NCTE, Regulations, 2009.




Hence, NRC decided that the recognition of the said course be refused under section 14/15 (3) (b) of NCTE Act, 1993.

NOW THEREFORE, in exercise of the powers vested under section 14/15(3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refused the above application of the institution i.e. Lala Jagat Naryan Education College, Plot/Khasra No-226,228, Street No.-Muktsar Road, Village-Chak Arian Wala, Post Office-Jalalabad West, Town/City – Jalalabad West, Tehsil/Taluka-Jalalabad West, District-Firozpur-152024, Punjab for M.Ed. Course on the grounds mentioned above.

If the institution is not satisfied by the above order they can prefer an appeal to the Council (NCTE, New Delhi) in terms of sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the issue of this order.


