AND WHEREAS, The inspection of the institution was conducted on 27.12.2013. The VTR of the institution was considered by NRC in its 224th Meeting and as per decision of NRC, letter of intent dated 25.02.2014 was issued to the institution.

AND WHEREAS, The Institution has not submitted the reply of the aforesaid letter. The matter was considered by NRC in its 232nd Meeting(2nd Sitting) and as per decision of NRC, Show Cause Notice dated 26.03.2015 was issued to the institution on the following points:

o The reply LOI issued on 25.02.2014, not submitted.

AND WHEREAS, The institution has not submitted the reply of the Show Cause Notice. The matter was carefully considered by NRC in its 239th Meeting and NRC decided to refuse the recognition of the institution on the following grounds:

o Reply of SCN dated 26.03.2015 is not submitted.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Hari College of Management, Plot/Khasara No.- 117/2, 118/3, 119, 120, 132/2, 132, Street Number- 0, Village- Urgrahu Ahtmai, Post Office-Gagalheri, Tehsil/Taluka- Saharanpur, Town/City- Saharanpur, District- Saharanpur, Pin Code- 247001, State- Uttar Pradesh for the B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.
