REFUSAL ORDER

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993, Dr. Rajendra Prasad Educational Society, Village - Jankipuram Extension, Post Office - Jankipuram, Tehsil - Sadar, Dist. - Lucknow (UP) 226021, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to City Womens College, Village - Jankipuram Extension, Post Office - Jankipuram, Tehsil - Sadar, Dist. - Lucknow (UP) 226021, for B.El.Ed. Course of Four years' duration on 30.05.2015.

AND WHEREAS, the matter was considered by NRC in its Emergent Meeting held from 15th to 17th March, 2016 and the Committee decided to issue Show Cause Notice under clause 14/15(3) (b) of NCTE Act, 1993, Accordingly, Show Cause Notice was issued on 06.04.2016 the following grounds: -

- Two faculty appointed as a lecturers in Linguistics are not qualified for the post.
- Proof of institution offering multiple/teachers education

AND WHEREAS, the institution did not submitted reply of Show Cause Notice. The matter was considered by NRC in its 272nd meeting held from 06th to 07th July, 2017. The Committee decided to refuse recognition to the institution on the following grounds:-

- The applicant institution has not submitted the reply of SCN within the stipulated period.

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuses recognition/permission sought by the institution i.e City Womens College, Village - Jankipuram Extension, Post Office - Jankipuram, Tehsil - Sadar, Dist. - Lucknow (UP) 226021, for B.El.Ed. Course on the ground mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE website.
