REFUSAL ORDER

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993 Haji Mohammad Israil Siksha Samiti. Plot No. - 857/858, Street/Road - Isha Garh Road, Village/Town/City - Mehmodpur Mafi, Post Office -Mehmodpur Mafi, Tehsil/Taluka - Bilari, Town/City - Moradabad, District - Moradabad, State - Uttar Pradesh 244001 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Khawaja Institute of Higher Education, Plot No. - 857/858, Street No. - Main Road, Village - Mehmodpur Mafi, Post Office - Mehmodpur Mafi, Tehsil/Taluka- Bilari, Town/City -Moradabad, District - Moradabad, State - Uttar Pradesh -244001 for D.El.Ed. Course of two years Duration on 30.06.2015

AND WHEREAS, the matter was considered by the NRC in its 249th (Part-2) meeting held from 01st to 10th February, 2016 and the Committee decided to constitute VT. The inspection was conducted on 15.02.2016.

AND WHEREAS, the VTR was considered by the NRC in its 256th (Part- 2) meeting held from 22nd to 25th August, 2016 and the Committee decided to issue Show Cause Notice on the following points: -

As per VT report no documents were produced by the institution. No CD/Photos was produced by the institution. Without any relevant document it was not possible to fill report proforma properly.

Accordingly Show Cause Notice was issued on 09,09,2016.

AND WHEREAS, the matter was considered by the NRC in its 271st meeting held from 07th to 09th June, 2017 and decided that the application is rejected and recognition/ permission is refused u/s 14/15 of the NCTE Act 1993 on the following points:

The applicant institution has not submitted the reply of SCN within the stipulated period.

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3)(b) of NCTE Act. 1993, the Northern Regional Committee hereby rejects the application of the institution i.e. Khawaja Institute of Higher Education, Plot No. - 857/858, Street No. - Main Road, Village - Mehmodpur Mafi, Post Office - Mehmodpur Mafi, Tehsil/Taluka- Bilari, Town/City - Moradabad, District - Moradabad, State - Uttar Pradesh -244001 for D.El.Ed. Course and recognition/ permission is refused on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 in the online mode available on NCTE's website www.ncte-india.org within 60 days from the issue of this order. The guidelines for filing appeal may be seen on the NCTE website.
