REFUSAL ORDER

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993 Indira Public Shikshan Samiti Nala Mohalla Dausa, Plot No. – 00, Stree/Road – Nala Mohaolla, Villagte/Town/City – Dausa, Post Office – Dausa, Tehsil/Taluka – Dausa, Town /City – Dausa, District – Dausa, State – Rajasthan, Pin Code – 303303. had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Indira Gandhi Teacher Training College, Plot/ Khasra No. – 399/2, Street No. – Baniyanard, Village – Jairampura, Post Offiace – Dausa, Tehsil/Taluka – Dausa, Town/City – Dausa, District – Dausa, State – Rajasthan, Pin Code – 303303. for B.Ed. Course of two years duration on 23.05.2015.

AND WHEREAS, Show Cause Notice before Summarily Rejection was issued to the institution on 06.11.2015 as per 243rd meeting of NRC held from 28th to 30th September, 2015 on the following points: -

- Failure to submit NOC of the affiliating body with the hard copy of the application.

AND WHEREAS, the matter was considered by the NRC in its 261st meeting held on 14th to 19th December, 2016 and the Committee decided to issue Show Cause Notice . Accordingly, SCN was issued to the institution on 05.01.2017 on the following points: -

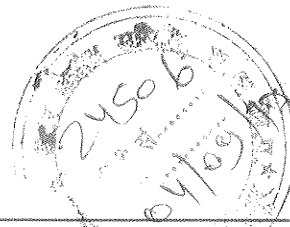
- The institution has not submitted the certified copy of the registered land documents duly certified by the Registrar/Sub-Registrar of the District.
- The institution has not submitted the Notarized copy of the Change of Land Use Certificate issued the Competent Govt. Authority.
- The institution has not submitted the approved Building plan signed by the Competent Govt. Authority indicating the name of the course, address of the institution, Khasra No./Plot No., Total land, total built – up area and the measurements of the Multi-purpose Hall as well as the other infrastructural facilities such as class rooms etc.
- The institution has not submitted any proof/evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014.
- The institution has not submitted Non- Encumbrance Certificate signed by the Competent Government Authority.


AND WHEREAS, the matter was considered by the NRC in its 271th meeting held from 07th to 09th June, 2017 and the Committee decided that the application is rejected and recognition/ permission is refused u/s 14/15 of the, NCTE Act 1993 on the following points:-

- The applicant institution has not submitted the reply of the SCN within the stipulated time.

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3)(b) of NCTE Act, 1993, the Northern Regional Committee hereby rejects the application of the institution i.e Indira Gandhi Teacher Training College, Plot/ Khasra No. – 399/2, Street No. – Baniyanard, Village – Jairampura, Post Offiace – Dausa, Tehsil/Taluka – Dausa, Town/City – Dausa, District – Dausa, State – Rajasthan, Pin Code – 303303. for M.Ed Course and recognition/ permission is refused on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 in the online mode available on NCTE's website www.ncte-india.org within 60 days from the issue of this order. The guidelines for filing appeal may be seen on the NCTE website.
