REFUSAL ORDER

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993 Mukundi Devi Kamla Yadav Uchch Shiksha Sansthan, Plot No.- 81, Village- Etawah, Post office- Etawah, Tehsil/Taluka- Etawah, Town/City- Etawah, Distt.- Etawah- 206001, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Sant Narayan Das College, Plot No.- 218, Village- Kamalpura, Post office- Shahpur Brahman, Tehsil/Taluka- Bah, Town/City- Jaitpur Kalan Bah, Distt.- Agra-283104, Uttar Pradesh for D.El.Ed. Course of two years Duration on 30.06.2015.

AND WHEREAS, the matter was considered by the NRC in its 256th (Part-2) meeting held from 22nd to 25th August, 2016 and the Committee decided to issue Show Cause Notice on the following points: -

- The institution has not submitted any proof / evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014.
- The institution has not submitted the Notarized copy of Change of Land use Certificate issued by the Competent Govt. Authority.
- Original building plan submitted does not bear approval of Competent Authority. The affidavit mentioning total area of land, address etc. with 100/- non-judicial stamp paper has not been submitted.

Accordingly Show Cause Notice was issued on 09.09.2016.

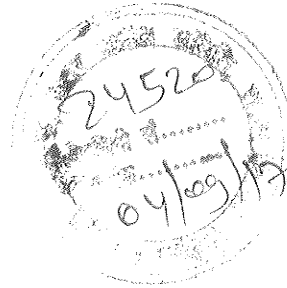
AND WHEREAS, the matter was considered by the NRC in its 271st meeting held from 07th to 09th June, 2017 and decided that the application is rejected and recognition/ permission is refused u/s 14/15 of the NCTE Act 1993 on the following points :-

- The applicant institution has not submitted the reply of SCN within the stipulated period.


NOW THEREFORE, in exercise of the powers vested under section 14/15 (3)(b) of NCTE Act, 1993, the Northern Regional Committee hereby rejects the application of the institution i.e. Sant Narayan Das College, Plot No.- 218, Village- Kamalpura, Post office- Shahpur Brahman, Tehsil/Taluka- Bah, Town/City- Jaitpur Kalan Bah, Distt.- Agra-283104, Uttar Pradesh for D.El.Ed. Course and recognition/ permission is refused on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 in the online mode available on NCTE's website www.ncte-india.org within 60 days from the issue of this order. The guidelines for filing appeal may be seen on the NCTE website.
