REFUSAL ORDER

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993, Prem Educational Charitable Trust, Plot No. 449, Village - Akabarpur, Post Office - Shyamo, Tehsil - Sadar, Dist. - Agra (UP) 283125, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to Shri Bhagwan Singh Girls College of Education And Technology, Plot No. 449, Village - Akabarpur, Post Office - Shyamo, Tehsil - Sadar, Dist. - Agra (UP) 283125, for D.El.Ed. Course of Two years duration on 27.05.2015.

AND WHEREAS, the matter was considered by NRC in its 253th (Part-2) meeting held from 10th to 13th June, 2016 and the Committee decided to issue Show Cause Notice under clause 14/15(3) (b) of NCTE Act, 1993. Accordingly, Show Cause Notice was issued on the following grounds: -

- *The institution is already running two units of B.Ed. and total built-up area is only 2092.03 sq.mts only. Thus it does not possess the built-up area for proposed course as required under NCTE norms.*

Hence, show cause notice under Section 14/15 (3)(b) of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice.

AND WHEREAS, the institution has submitted reply of Show Cause Notice on 29.06.2016. The matter was considered by NRC in its 263rd (Part-1) meeting held from 06th to 11th February, 2017. The Committee decided to refuse recognition to the institution on the following grounds: -

- *The institution was given recognition for B.Ed. (100) seats vide Order dated 15.5.2014 on Khasara No. 449. Institution has again submitted application for D.El.Ed. course on same Khasara No. 449 with total built up area of 2092.03 sq.m. and total land area of 2650 sq.m. Institution was given SCN. Reply submitted by institution indicates that land area and total built up area is less than as required for running both the courses, as per NCTE Regulations, 2014.*

Hence, the Committee decided that the application is rejected and recognition/ permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution.

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuses recognition/permission sought by the institution i.e. Shri Bhagwan Singh Girls College of Education and Technology, Plot No. 449, Village - Akabarpur, Post Office - Shyamo, Tehsil - Sadar, Dist. - Agra (UP) 283125, for the D.El.Ed. Course on the ground mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE website.

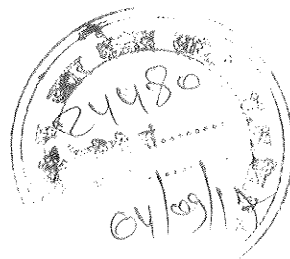
