REFUSAL/REJECTION ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Nova Educational Trust, Plot Number- 74, Street/Road- Bhaissaura, Village/Town/City- Bhaissaura, Post Office- Chinhat, Tehsil/Taluka- Sadar, Town/City- Lucknow, District- Lucknow (UP), State- UP, Pin Code- 226010 had submitted an application i.e. NRCAPP-13220 to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Nova Institute of Education, Plot Number- 74, Street/Road- 74, Village/Town/City- Bhaissaura, Post Office- Chinhat, Tehsil/Taluka- Sadar, Town/City- Lucknow, District- Lucknow (UP), State- UP, Pin Code- 226010 for D.El.Ed. course on 03.06.2015.

AND WHEREAS, the matter was considered in NRC in its 266th meeting (part-1-B) and committee decided to issue Show Cause Notice on the following grounds. Accordingly show cause notice issued on 30.03.2017.

- The institution has not submitted any proof / evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014.
- The institution has not submitted the certified registered land documents issued by the Registering Authority or civil authority concerned.
- The land documents, NEC, LUC are in the name of Nova Hospital Limited whereas the name of the applicant Trust is Nova Educational Trust.

AND WHEREAS, the institution has not submitted reply of Show Cause Notice. The matter was considered by NRC in its 270th (Part-2) Meeting held from 29th to 30th May, 2017 and the Committee decided that the application of the institution for grant of recognition/permission is refused on the following grounds: -

- The applicant institution has not submitted the reply of SCN within the stipulated period.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby rejects the said application of the institution i.e. Nova Institute of Education, Plot Number- 74, Street/Road- 74, Village/Town/City- Bhaissaura, Post Office- Chinhat, Tehsil/Taluka- Sadar, Town/City- Lucknow, District- Lucknow (UP), State- UP, Pin Code- 226010 and recognition/permission is refused on the grounds mentioned above.

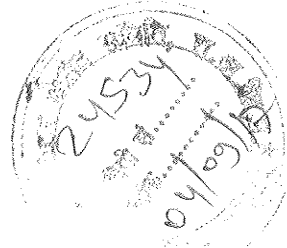
