REFUSAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, Swargiya Devi Baksh Singh Shiksha Simiti, Plot Number- 1031, Street /Road- Rudauli Amaniganj Road, Village/Town/City- Amaniganj, Post Office - Amaniganj, Tehsil/Taluka- Milkipur, Town/City- Faizabad, District- Faizabad (UP), State - Uttar Pradesh, Pin Code - 234543 had applied in the office of NRC for seeking recognition for conducting B.Ed. Course of on year duration with an annual intake of 100 (One Hundred Only) Students on 07.01.2013 in the proposed Institution i.e. DBS Memorial Institute of Education, Plot / Khasra Number- 1031, Street /Road- Amaniganj, Village- Chandaura, Post Office - Chandaura, Tehsil/Taluka- Milkipur, Town/City- Firozabad, District- Firozabad (UP), State - Uttar Pradesh, Pin Code - 224121.

AND WHEREAS, The inspection of the institution was conducted on 05.01.2014. The VTR of the institution was considered by NRC in 225th Meeting and as per decision of NRC, letter of intent under clause 7(9) of NCTE Regulations, 2009 dated 06.03.2014 was issued to the institution.

AND WHEREAS The institution has not submitted its reply of letter of intent. The matter was considered by NRC in 232nd Meeting and as per decision of NRC, Show Cause Notice dated 26.03.2015 was issued to the institution on the following grounds:

- o Reply of LOI issued on 6/3/2014 is not submitted.

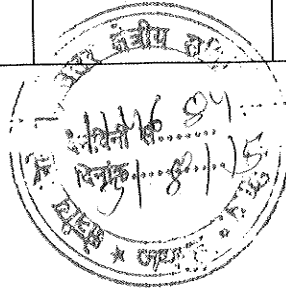
AND WHEREAS, The institution has not submitted its reply of the Show Cause Notice. The matter was again considered by NRC in its 239th Meeting and NRC decided to refuse the application of the institution on the following grounds:


- o The institution has not responded to the SCN No. 91742 dated 26.03.2015 regarding no reply of LOI issued on 06.03.2014 within stipulated time. Hence, the application is rejected.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. DBS Memorial Institute of Education, Plot / Khasra Number- 1031, Street /Road- Amaniganj, Village- Chandaura, Post Office - Chandaura, Tehsil/Taluka- Milkipur, Town/City- Firozabad, District- Firozabad (UP), State - Uttar Pradesh, Pin Code - 224121 for the B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.org within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.
