REFUSAL ORDER

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993 Dr. Radhakrishnan Education and Welfare Trust Basni, Plot No-KH No.-8614, Village/Town/City-Baswa, Post office-Baswa, Tehsil/Taluka-Baswa, Town/City-Baswa, District-Dausa, State-Rajasthan, Pin Code-303327 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Dr. Radhakrishnan BSTC College, Plot No-KH-No.- 8614, Village-Baswa, Post Office-Baswa, Tehsil/Taluka-Baswa, Town/City-Baswa, District-Dausa, State-Rajasthan, Pin Code-303327 for D.El.Ed. Course of two years duration on 07.07.2015.

AND WHEREAS, the matter was considered by the NRC in its 248th (Part-8) meeting held from 11st to 24th January, 2016 and Committee decided to issue Show Cause Notice on the following points: -

- The institution has not submitted proof of composite institution.

Accordingly, the SCN was issued to the institution on 27.05.2017.


AND WHEREAS, the matter was considered by the NRC in its 274th meeting held from 29th to 31st August, 2017 and decided that the application is rejected and recognition/ permission is refused u/s 14/15 of the NRC, NCTE Act 1993 on the following points :-

- The institution has not submitted the reply of Show Cause Notice till date.

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3)(b) of NCTE Act, 1993, the Northern Regional Committee hereby rejects the application of the institution i.e. Dr. Radhakrishnan BSTC College Baswa, Plot No-KH-No.- 8614, Village-Baswa, Post Office-Baswa, Tehsil/Taluka-Baswa, Town/City-Baswa, District-Dausa, State-Rajasthan, Pin Code-303327 for D.El.Ed. Course and recognition/ permission is refused on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 in the online mode available on NCTE's website www.ncte-india.org within 60 days from the issue of this order. The guidelines for filing appeal may be seen on the NCTE website.
