REFUSAL ORDER

- 9 SEP 2017

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993 Wagar Janjati and Vikas Sansthan, Street/Road-Mahan Colony, Village/Town/City-Banswara, Post office-Banswara, Tehsil/Taluka-Banswara, Town/City-Banswara, District-Banswara, State-Rajasthan, Pin Code-327001 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Ashish College Talwara, Plot No-00, Street Number-00, Village-Talwara, Post Office-Talwara, Tehsil/Taluka-Banswara, Town/City-Talwara, District-Banswara, State-Rajasthan, Pin Code-327025 for D.El.Ed. Course of two years duration on 01.06.2015.

AND WHEREAS, the matter was considered by the NRC in its 252nd (Part-10) meeting held from 19th April to 02nd May, 2016 and Committee decided to issue Show Cause Notice on the following points :-

- The institution has not submitted any proof / evidence that it is a composite institution as per clause 2.b of NCTE Regulations, 2014.
- The institution has not submitted following land related required documents :-
 - Copies of registered land documents certified by the competent revenue authority.
 - Non Encumbrance Certificate issued by competent authority.
 - Notarized copy of CLU issued by the competent authority.

Accordingly, the SCN was issued to the institution on 22.05.2017.


AND WHEREAS, the matter was considered by the NRC in its 274th meeting held from 29th to 31st August, 2017 and decided that the application is rejected and recognition/ permission is refused u/s 14/15 of the NRC, NCTE Act 1993 on the following points :-

- The institution has not submitted the reply of Show Cause Notice till date.

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3)(b) of NCTE Act, 1993, the Northern Regional Committee hereby rejects the application of the institution i.e. Ashish College Talwara, Village-Talwara, Post Office-Talwara, Tehsil/Taluka-Banswara, Town/City-Talwara, District-Banswara, State-Rajasthan, Pin Code-327025 for D.El.Ed. Course and recognition/ permission is refused on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 in the online mode available on NCTE's website www.ncte-india.org within 60 days from the issue of this order. The guidelines for filing appeal may be seen on the NCTE website.
