REFUSAL/REJECTION ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Sunrise Academy management Society, Plot/Khasara No.-298(min), Street No.-Raipur Road, Village-Dehradun, Post office-GPO, Tehsil/Taluka-Dehradun, Town/city-Dehradun, District-Dehradun-248001, State-Uttarakhand Pincode-248001 had submitted an application i.e. NRCAPP-10976 to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Narendra Singh Rawat, Plot/Khasara No.-296(min), 298(min), 299(min), Street No.-Raipur Road, Village-Dehradun, Post office-GPO, Tehsil/Taluka-Dehradun, Town/city-Dehradun, District-Dehradun-248001, State-Uttarakhand Pincode-248001, for B.Ed (add. Intake) course on 28.05.2015.

AND WHEREAS, the matter was considered by NRC in its 243rd Meeting held on 28th to 30th September, 2015 and the Committee decided to issue Show Cause Notice on the following grounds:-

- Failure to submit. "document such as No Objection Certificate issued by the concerned affiliating body".

Accordingly, show cause notice was issued on 19.10.2015.

AND WHEREAS, the institution did not submit reply of Show Cause Notice. The matter was considered in NRC in its 251st Meeting (part-1) held on 07th to 09th April, 2016 and the Committee decided that the application of the institution for grant of recognition/permission is refused on the following grounds: -

- The institution has not submitted reply of Show Cause Notice.

Accordingly, refusal order was issued to the institution on 14.07.2016.

AND WHEREAS, the above institution preferred an appeal before the Council (New Delhi) under section 18 of the NCTE Act, 1993. The Appellate Authority had passed order dt. 29.05.2017 in the appeal. The operative part of appeal is as under: -

- Appeal Committee, therefore, decided to remand back the case to NRC to re-examine the matter afresh and in case the NOC submitted by applicant is not acceptable, issue a fresh SCN on the exact deficiencies notices in the said certificate.
- After perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to NRC for reconsidering the matter.
- The Council hereby remands back the case of Narendra Singh Rawat (Sunrise Academy Management Society), Dehradun, Uttarakhand to the NRC, NCTE, for necessary action as indicated above.

AND WHEREAS, the matter was considered by NRC in its 272nd Meeting held on 06th to 07th July, 2017 and the Committee decided to issue Show Cause Notice on the following grounds:-

- In compliance of the order of the NCTE Hqrs. dated 29.05.2017, the matter was considered by the NRC. NRC decided that SCN be issued to the applicant institution with regard to the letter of the Govt. of Uttrakhand, dated 19.06.2017.

Accordingly, show cause notice was issued on 14.09.2017.

AND WHEREAS, the institution has submitted its reply in NRC office on 03.10.2017. The matter was considered by NRC in its 277th Meeting held on 05th to 06th December, 2017 and the Committee decided that the application of the institution for grant of recognition/permission is refused on the following grounds: -

- There is a ban in the State for grant of recognition for B.Ed. course/Additional Intake in B.Ed.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby rejects the said application of the institution i.e. Narendra Singh Rawat, Plot/Khasara No.-296(min), 298(min), 299(min), Street No.-Raipur Road, Village-Dehradun, Post office-GPO, Tehsil/Taluka-Dehradun, Town/city-Dehradun, District-Dehradun-248001, State-Uttarakhand Pincode-248001 and recognition/permission is refused on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under Sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of this order. The guidelines of appeal may be seen on NCTE Website.
