REFUSAL ORDER

23 JAN 2018

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993, Nabav Samajik Avm Shaikshanik Sansthan, Plot No. - N.A., Village - Mehra Colony, Post Office - Shikohabad, Tehsil/Taluka - Shikohabad, Dist. - Firozabad, UP - 205135, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. SDRBL Sheela Devi Ram Bharose Lal Mahavidyalaya, Plot No. - 24&25S, Village - Aronj, Post Office - Shikohabad, Tehsil/Taluka - Shikohabad, Dist. - Firozabad, UP -205135, for B.Ed. Course of two years Duration on 27.12.2012.

AND WHEREAS, Deficiency letter was issued on 17.04.2013.

AND WHEREAS, the institution submitted reply, received on 03.06.2013.

AND WHEREAS, the matter was considered by the NRC in its 219th meeting held from 26th to 29th September, 2013 and the Committee decided to constitute VT. The inspection was conducted on 09.11.2013.

AND WHEREAS, the VTR was considered by the NRC in its 239th meeting held from 30th June to 1st July, 2015 and the committee decided to issue Show Cause Notice to the institution on the following grounds: -

- The original building completion certificate in the prescribed proforma has not been submitted.
- The institution to submit unedited CD of the inspection by the VT done on 09.11.2013.

Accordingly, Show Cause Notice was issued on 20.06.2015 to the institution.

AND WHEREAS, the institution submitted reply of the Show Cause Notice received on 16.07.2015 The matter was considered by the NRC in its 241st meeting held from 03rd to 07th August, 2015 and the Committee decided to issue Letter of Intent. (LOI)

Accordingly, Letter of Intent was issued to the institution on 21.08.2015.

AND WHEREAS, the matter was considered by the NRC in its 256th meeting held from 22nd to 25th August, 2016 and the Committee decided to issue Show Cause Notice to the institution.

- The institution was given letter of intent under clause 7(13) of NCTE Regulation, 2014 vide letter dt. 21.08.2015. The institution did not submit any reply of letter of intent.

Accordingly, Show Cause Notice was issued to the institution on 04.10.2016.

AND WHEREAS, the institution submitted reply of the Show Cause Notice received on 02.11.2016 The matter was considered by the NRC in its 263rd meeting (Part-1) held from 06th to 11th to February, 2017 and the Committee decided to reject the application and recognition/ permission is refused u/s 14/15 (3)(b) of the NCTE on the following grounds: -

- Institution was given SCN dated 04.10.2016 to submit reply of the LOI. Reply submitted by institution is not acceptable as institution has not submitted list of faculty duly approved by the affiliating body along with other documents.
