REFUSAL ORDER

WHEREAS, in terms of Section 14/15(1) of the NCTE Act, 1993 Takhat Singh Memorial Institute of Education and Research, Plot No.- 350, Street No.- Urban Estate Phase 1, Village- Patiala, P.O.- Patiala, Tehsil- Patiala, Town- Patiala, District- Patiala(PB), Pin Code- 147002, State- Punjab, submitted an application to the Northern Regional Committee of NCTE on 31.12.2012 for grant of recognition/permission to Noor College of Education, Plot No.- 37//12/2, Street No.- 00, Village- Budhanpur, P.O.- Punjabi University, Tehsil- Patiala, Town- Patiala, District- Patiala(PB), Pin Code- 147002, State- Punjab for B.Ed. Course of Two years duration.

AND, WHEREAS, the matter was placed before NRC in its 263rd meeting(Part-I-06.02.2017) held from 06th to 11th February, 2017 and the Committee decided to issue Show Cause Notice u/s 14/15(3) (b) of the NCTE Act, 1993 giving 30 days time for submission of reply on the following grounds:-

- Reply of the Deficiency letter issued on 25.07.2013 has not been submitted till date.

AND, WHEREAS, Show Cause Notice was issued on 04.04.2017 to the institution.

AND, WHEREAS, the institution did not submit reply of Show Cause Notice.

AND, WHEREAS, the matter was considered by NRC in its 279th meeting held from 16th to 17th January, 2018 and the Committee decided as under:-

- The institution has not submitted reply of SCN issued on 04.04.2017 till date.

Hence, the Committee decided that the application is rejected and recognition/ permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution.

NOW, THEREFORE, in exercise of the powers vested under Section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuses recognition/ permission to the institution on the grounds mentioned above. The FDRs in original are returned herewith.

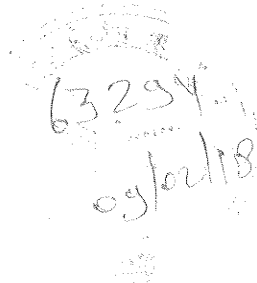
