REFUSAL ORDER

WHEREAS, in terms of Section 14/15(1) of the NCTE Act, 1993, Shri Rustam Singh Cheritable Trust, Plot No.- 331, 332, Street/Road- Noorampur, Village- Post Bainsroli, Post office- Bainsroli, Tehsil/Taluka- Bhongaon, Town/City- Mainpuri, Distt. - Mainpuri, Uttar Pradesh-205001, had submitted an application to the Northern Regional Committee of NCTE on 30.06.2015 for grant of recognition/permission to Maa Vaishno College of Education, Plot No.- 331, 332, Street No.- Puthriroad, Village- Nabada, Post office- Shirol, Tehsil/Taluka- Sadar, Town/City- Farrukhabad, Distt.- Farrukhabad, Uttar Pradesh-209601 for D.El.Ed. Course of two years duration .

AND, WHEREAS, the matter was placed before NRC in its 243<sup>rd</sup> meeting held from 28<sup>th</sup> to 30 September, 2015 and the Committee decided to issue Show Cause Notice u/s 14/15(3) (b) of the NCTE Act, 1993 giving 30 days' time for submission of reply on the following grounds: -

- Failure to submit printout of the applications made online within 15 days of the submission of online application.
- Failure to furnish the application fee, as prescribed under rule 9 of the NCTE Rules 1997 of before the date of submission of online application. (The institution mention online application DD No. 256099 dt. 29.06.2015 but submitted with hard copy in DD No. 28559 dt. 14.07.2015 after online

AND, WHEREAS, Show Cause Notice was issued on 18.12.2015 to the institution.

AND, WHEREAS, the institution did not submit reply of Show Cause Notice.

AND, WHEREAS, the matter was considered by NRC in its 279<sup>th</sup> meeting held from 16<sup>th</sup> to 17<sup>th</sup> and the Committee decided as under: -

- The institution was issued SCN. The institution has not submitted reply of SCN within stipulated time.

Hence, the Committee decided that the application is rejected and recognition/ permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution.

NOW, THEREFORE, in exercise of the powers vested under Section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuses recognition/ permission to the institution on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.


