Refusal Order

AND WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, 1993 Haldhar Vidya Mandir Ajuha Kausi, Plot Number- 54/1, Street/Road- Sayara, Village/Town/City- Sayara, Post Office- Sayara, Tehsil/Taluka- Sirathu, Town/City- Sayara, District- Kaushambi (UP), State- UP, Pin Code- 212217, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Sri Babu Singh Degree College, Plot / Khasra Number- 54/1, 49, Street/Road- 00, Village/Town/City- Sayara, Post Office- Sayara, Tehsil/Taluka- Sayara, Town/City- Sayara, District- Kaushambi(UP), State- UP, Pin Code- 212217, for B.Ed. Course of one year duration for an intake of 100 seats students on 31.12.2012.

AND WHEREAS, the Northern Regional Committee, National Council for Teacher Education in its 234th Meeting considered the case and NRC decided to issue a Show Cause Notice under clause 14/15 (3) (b) of the NCTE Act 1993. Accordingly, Show Cause Notice was issued to the institution on 28.05.2015 on the following grounds.

- Remaining amount i.e. Rs. 4.00 Lakhs from nationalized bank towards Reserve Fund (Rs. 7.00 lakhs) has not been submitted as per NCTE Regulations, 2014.
- No Objection Certificate from affiliating university / body has not been submitted by the institution.
- The institution dispatched the hard copy of the online application form on 08.01.2013 which was received in the office of NRC on 04.02.2013, which is not within 7 days from the date of online application as required in NCTE Regulations, 2014.
- The specific information land / building, demarcated area as per the NCTE Regulations, 2014 and information related to resolution of the society for opening the said course not for profit etc. has not given by the institution, hence, the same is required from the institution in the affidavit (format of the affidavit is enclosed herewith).

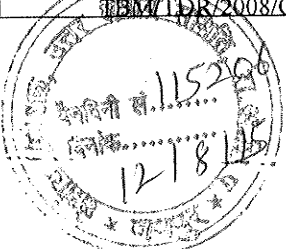
AND WHEREAS, the matter was considered by NRC in its 240th Meeting held from 20th to 22nd July, 2015 and it was decided that the application of the institution be refused on the following grounds :


- Reply submitted by the institution is not acceptable, Hence application is refused.

NOW THEREFORE, in exercise of the powers vested under section 14/15(3)(b) of NCTE Act, 1993, the Northern Regional Committee hereby refused the above application of the institution i.e. Sri Babu Singh Degree College, Plot / Khasra Number- 54/1, 49, Street/Road- 00, Village/Town/City- Sayara, Post Office- Sayara, Tehsil/Taluka- Sayara, Town/City- Sayara, District- Kaushambi(UP), State- UP, Pin Code- 212217, for 100 seats in the B.Ed. course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of this order.
