REFUSAL/REJECTION ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Rajesh pilot Educational Foundation, Plot Number/Khasara No.- NA, Street/Road- NA, Village/Town/City-Shakalpura, Post Office- Chirori, Tehsil/Taluka-Loni, Town/City-NA, District- Ghaziabad(UP), State- Uttar Pradesh, Pin Code-201102 had submitted an application i.e. NRCAPP-13756 to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Rajesh Pilot Mahavidyalaya, Plot Number/Khasara No.- 473,479,1113,1114,1119, 1147,11, Street/Road- NA, Village/Town/City-Shakalpura, Post Office- Chirori, Tehsil/Taluka-Loni, Town/City-NA, District- Ghaziabad(UP), State- Uttar Pradesh, Pin Code-201102 for D.El.Ed course on 22.06.2015.

AND WHEREAS, the matter was considered by NRC in its 250<sup>th</sup> meeting (part-1) held on 19<sup>th</sup> -20<sup>th</sup> February, 2016 and the Committee decided that VT be constituted. The inspection of the institution was conducted on 01.03.2016 by the visiting team constituted by NRC.

AND WHEREAS, the matter was considered by NRC in its Emergent meeting held on 15<sup>th</sup> to 17<sup>th</sup> March, 2016 and the Committee decided to issue letter of intent. Accordingly, letter of intent was issued on 10.05.2016.

AND WHEREAS, the matter was considered by NRC in its 261<sup>st</sup> meeting held on 14<sup>th</sup> to 19<sup>th</sup> December, 2016 and the Committee decided to issue Show Cause Notice on the following grounds:-

- The institution has not submitted the reply of letter of intent under clause 7(13) of the NCTE Act, 1993 issued by the NRC, NCTE on 10.05.2016.

Accordingly, show cause notice was issued on 26.12.2016.


AND WHEREAS, the institution did not submit reply of Show Cause Notice. The matter was considered by NRC in its 275<sup>th</sup> Meeting held from 16<sup>th</sup> to 18<sup>th</sup> and 19<sup>th</sup> to 21<sup>st</sup> September, 2017 (part-1) and the Committee decided that the application of the institution for grant of recognition/permission is refused on the following grounds:-

- LOI was issued on 10.05.2016, no reply was submitted by the institution. SCN was issued by NRC on 26.12.2016. No reply of SCN has been received.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby rejects the said application of the institution i.e. Rajesh Pilot Mahavidyalaya, Plot Number/Khasara No.- 473,479,1113,1114,1119, 1147,11, Street/Road- NA, Village/Town/City-Shakalpura, Post Office- Chirori, Tehsil/Taluka-Loni, Town/City-NA, District- Ghaziabad(UP), State- Uttar Pradesh, Pin Code-201102 and recognition/permission is refused on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under Sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of this order. 
