REFUSAL ORDER

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993 Muhammad And Muhammad Muslim Welfare Society, Plot No. 301, Village - Etah, Post Office- Etah, Tehsil -Etah, Dist. - Etah (UP) 207001, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to Taj Teacher Training College, Plot No. 220, Village - Kasimpur Bhadurgarh, Post Office- Etah, Tehsil -Etah, Dist. - Etah (UP) 20700, for D.El.Ed. Course of Two years' duration on 30.05.2015.

AND WHEREAS, the matter was placed before the NRC in its 256th meeting (Part-2) held on 22nd to 25th August, 2016 and the Committee decided to issue show cause notice on the following grounds:-

- *The institution has not mentioned any thing in its application that it offers general higher education courses or its offers other teacher education programmes. The institution must submit a proof that it is a composite institution offering general higher education courses and/or other teacher education programmes in the campus. The copy of the NOC of DPSE submitted by the institution is not considered as an evidence of composite institution, since at present no such teacher education course is being run by the institution.*

Accordingly, SCN was issued to the institution on 22.07.2017.


AND WHEREAS, the institution did not submit reply of Show Cause Notice. The matter was considered by NRC in its 277th meeting held from 05th to 06th December, 2017. The Committee decided to refuse recognition to the institution on the following grounds:-

- *The institution has not submitted the reply of SCN issued to it on 22.07.2017.*

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuses recognition/permission sought by the institution i.e Taj Teacher Training College, Plot No. 220, Village - Kasimpur Bhadurgarh, Post Office- Etah, Tehsil -Etah, Dist. - Etah (UP) 20700, for D.El.Ed. Course on the ground mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE website.
