WHEREAS, in terms of section 14(1) of the NCTE Act, 1993, the Society namely, **Narendra Kumar Balye Ram Educational Society, Plot No. – L-823, Street/Road –Shastri Nagar, Village/Town/City –Meerut, Post Office – Medical College Campus, Tehsil/Taluka –Meerut, Town/City –Meerut, District –Meerut, State – Uttar Pradesh – 250004** had submitted an application to the Northern Regional Committee of NCTE for grant of recognition / seeking permission to the institution i.e. **NKBR College of Professional Studies, Plot/Khasara No. – 482, Village-Phaphunda, Post Office –Kharkhauda, Tehsil/Taluka –Meerut, Town/City –Meerut, District – Meerut, State – Uttar Pradesh – 245206** for B.Ed. Course in the office of NRC on 03.01.2013.

AND WHEREAS, the deficiency letter was issued to the institution on 06.05.2013. The reply submitted by the institution in response to deficiency letter was considered by the NRC in its 219th meeting held from 26th to 29th September, 2013 and NRC decided VT be constituted. Accordingly, VT constitute vide this office letter dated 05.11.2013 and the inspection of the institution was conducted u/s 14 on 23.11.2013.

AND WHEREAS, the VTR was considered by the NRC in its 224th meeting held from January 28th to February 02nd, 2014 and it was decided to issue show cause notice on the following points:-

- Institution has in sufficient arrangements and infrastructural facilities in the ICT resource centre & psychology resource centres.
- Application for M.Ed. course of the institution already in the process. Hence two application u/c 8(2) of NCTE Regulations, 2009 cannot be considered.

AND WHEREAS, the reply dated 25.03.2014 received from the institution in response to the Show Cause Notice has been received in NRC office on dated 02.04.2014. The matter was considered by the NRC in its 232nd meeting held from (1st Sitting) held from 2nd to 6th February, 2015, 2015 NRC decided to issue letter of intent under clause 7(13) of NCTE Regulations, 2014 prior to grant of formal recognition. Accordingly, a letter of intent was issued to the institution on 26.02.2015. The reply of a letter of intent has not been received in NRC office.

AND WHEREAS, NCTE notified the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2014 in the Gazette of India on 01.12.2014, vide Notification dated 28.11.2014 NCTE also sent the Guidelines to the Regional Committees for processing of pending applications in view of notification of Regulations, 2014.

AND WHEREAS, the matter was considered by NRC in its 238th Meeting held from May 20-31, 2015 (Part-VI) and it was decided to issue show cause notice. Accordingly, Show Cause Notice was issued to the institution on 04.06.2015 on the following points:-


- *The institution has not submitted reply of letter of intent.*

AND WHEREAS, a letter dated 08.06.2015 & 17.06.2015 received from the institution in the NRC office on dated 11.06.2015 & 24.06.2015. The matter was considered by the NRC in its 240th meeting held on 20th to 22nd July, 2015 and NRC decided that recognition/permission to the institution is refused for B.Ed. course under Section 14(3)(b) of the NCTE Act, 1993 on the following points:

- The institution has not submitted reply of show cause notice.

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refused the recognition to the institution i.e. **NKBR College of Professional Studies, Plot/Khasara No. – 482, Village-Phaphunda, Post Office –Kharkhauda, Tehsil/Taluka –Meerut, Town/City –Meerut, District – Meerut, State – Uttar Pradesh – 245206** for B.Ed. course on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the “**online mode**” available on NCTE’s website www.ncte-india.org within 60 days from the issue of this order.
