Refusal Order

WHEREAS, in terms of section 14(1) of the NCTE Act, 1993, the Society namely, Graduate School of Business and Administration, Plot No.- HS- 02, Street/Road- Sector Alpha- 02, Village/Town/City- Greater Noida, Post Office- Alpha-1, Greater Noida, Tehsil/Taluka- Dadri, Town/City- Gautam Buddha Nagar, District- Gautam Buddha Nagar, State- Uttar Pradesh- 201310 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition / seeking permission to the institution i.e. Graduate School of Business and Administration, Plot No.- HS-02, Street No.- Block F, Village-Dadri, Post Office- Gautam Buddha Nagar, Tehsil/Taluka- Dadri, Town/City- Greater Noida, District- Gautam Buddha Nagar, State- Uttar Pradesh- 201310 for B.Ed. Course in the office of NRC on 02.01.2013.

AND WHEREAS, the deficiency letter was issued to the institution on 22.04.2013. The reply submitted by the institution in response to deficiency letter was considered by the NRC in its 219th meeting held from 26th to 29th September, 2013 and NRC decided to issue Show Cause Notice to the institution under section 14/15 (3) (b) of the NCTE Act 1993. Accordingly, Show Cause Notice was issued to the institution on 18.10.2013 on the following point:-

- Demarcated map & site plan showing facilities for different courses duly approved by the competent authority has not been submitted.

AND WHEREAS, the reply dated 30.10.2013 has been received from the institution in response to the Show Cause Notice on NRC office on dated 07.11.2013. The matter was considered by the NRC in its 222nd meeting held from December, 24th to 28th, 2013 and NRC decided VT be constituted. Accordingly, VT constitute vide this office letter dated 24.02.2014 and the inspection of the institution was conducted u/s 14 on 13.03.2014.

AND WHEREAS, the VTR was considered by the NRC in its 231st meeting held from 21-24 January, 2015 and NRC decided to issue letter of intent under clause 7(13) of NCTE Regulations, 2014 prior to grant of formal recognition. Accordingly, a letter of intent was issued to the institution on 07.02.2015. The reply of a letter of intent has not been received in NRC office.

AND WHEREAS, the matter was considered by NRC in its 238th Meeting held from May 20-31, 2015 and it was decided to issue show cause notice. Accordingly, Show Cause Notice was issued to the institution on 04.06.2015 on the following points:-

- The institution has not submitted reply of letter of intent.

AND WHEREAS, a reply dated 22.06.2015 & 22.06.2015 received from the institution in response to the Show Cause Notice has been received in NRC office on dated 23.06.2015 & 01.07.2015. The matter was considered by the NRC in its 240th meeting held on 20th to 22nd July, 2015 and NRC decided that recognition to the institution is refused for B.Ed. course under Section 14(3)(b) of the NCTE Act, 1993 on the following points:-


- The show cause notice was issued to the institution. The institution has not submitted faculty duly approved by the affiliating body, joint FDRs and copy of printout of website.

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refused the recognition to the institution i.e. Graduate School of Business and Administration, Plot No.- HS-02, Street No.- Block F, Village-Dadri, Post Office- Gautam Buddha Nagar, Tehsil/Taluka- Dadri, Town/City- Greater Noida, District- Gautam Buddha Nagar, State- Uttar Pradesh- 201310 for B.Ed. course on the grounds mentioned above.




If the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the issue of this order.
