WHEREAS, in terms of section 14(1) of the NCTE Act, 1993, the Society namely, **Ideal Educational Society**, Plot No.-SD-522, Street No.- D Block, Village- Shastri Nagar, P.O.- Kavi Nagar, Tehsil/Taluka – Ghaziabad, Town/City – Ghaziabad, District – Ghaziabad, State – Uttar Pradesh-201001 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition / seeking permission to the institution i.e. **IAMR Girls College of Education**, Plot No.-413, 411, Street No.-8, Village- Duhai, P.O.- Duhai, Tehsil/Taluka – Ghaziabad, Town/City – Ghaziabad, District – Ghaziabad, State – Uttar Pradesh-201206 for B.Ed. Course in the office of NRC on 02.01.2013.

AND WHEREAS, the deficiency letter was issued to the institution on 16.04.2013. The reply submitted by the institution in response to deficiency letter was considered by the NRC in its 218th meeting held from August 27th to 31st, 2013 and NRC decided to issue Show Cause Notice to the institution under section 14/15 (3) (b) of the NCTE Act 1993. Accordingly, Show Cause Notice was issued to the institution on 19.09.2013 on the following point:-

- *Demarcated building map having Khasra Number, Name of proposed course, size of all the facilities etc. duly approved by Competent Authority is not submitted.*
- *Notarized copy of change of land use certificate issued under clause 143 of UP land Act by the competent authority has not submitted.*
- *Certified copies of the land documents in respect of plot numbers as mentioned in the application duly registered in the office of Registrar / Sub - Registrar has not been submitted.*

AND WHEREAS, the reply dated 24.09.2013 has been received from the institution in response to the Show Cause Notice on NRC office on dated 28.11.2013. The matter was considered by the NRC in its 224th meeting held from January 28th to February 2nd, 2014 and NRC decided VT be constituted. Accordingly, VT constitute vide this office letter dated 25.02.2014 and the inspection of the institution was conducted u/s 14 on 11.03.2014.

AND WHEREAS, the VTR was considered by the NRC in its 231st meeting held from 21-24 January, 2015 and NRC decided to issue letter of intent under clause 7(13) of NCTE Regulations, 2014 prior to grant of formal recognition. Accordingly, a letter of intent was issued to the institution on 07.02.2015. The reply of a letter of intent dated 07.02. 2015 has not been received in NRC office.

AND WHEREAS, NCTE notified the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2014 in the Gazette of India on 01.12.2014, vide Notification dated 28.11.2014 NCTE also sent the Guidelines to the Regional Committees for processing of pending applications in view of notification of Regulations, 2014.

AND WHEREAS, the matter was considered by NRC in its 238th Meeting held from May 20-31, 2015 and it was decided to issue show cause notice. Accordingly, Show Cause Notice was issued to the institution on 04.06.2015 on the following points:-

- *The institution has not submitted reply of letter of intent.*


AND WHEREAS, a letter dated 22.06.2015 received from the institution in in NRC office on dated 01.07.2015. The matter was considered by the NRC in its 240th meeting held on 20th to 22nd July, 2015 and NRC decided that recognition to the institution is refused for B.Ed. course under Section 14(3)(b) of the NCTE Act, 1993 on the following points:-

- The institution was issued letter of intent on 7th February, 2015 with the direction to accomplish the requirements within a period of 60 days.
- Since, no reply was received within the stipulated period, a SCN was issued on 04.06.2015
- The institution has not submitted the list of faculty approved by the affiliating body till date.
- Institution has not submitted the downloaded copies of website of the institution with hyper links as required under NCTE Regulations, 2014.
- Joint FDRs of Reserve fund and Endowment have not been submitted.



NOW THEREFORE, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refused the recognition to the institution i.e. IAMR Girls College of Education, Plot No.-413, 411, Street No.-8, Village- Duhai, P.O.- Duhai, Tehsil/Taluka – Ghaziabad, Town/City – Ghaziabad, District – Ghaziabad, State – Uttar Pradesh-201206 for B.Ed. course on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the “online mode” available on NCTE’s website www.ncte-india.org within 60 days from the issue of this order.
