Refusal Order

WHEREAS, in terms of section 14/15(1) of the NCTE Act, 1993, Puran Education Society, Plot No. – 84/5/2, 6/1, Street/Road – Pehowa Road, Village/ Town/City- Josar (Jyotisar), Post Office – Jyotisar, Tehsil/Taluka – Thanesar, Town/City – Jyotisar, District- kurukshetra-136119, State- Haryana, had submitted an application to the Northern Regional Committee of NCTE on 27.12.2012 for grant of recognition / permission to the institution i.e. MA Durga Puran College of Education, Plot No.-84/5/2, 6/1, Street No.-428, Village- Josar(Jyotisar), Post Office- Jyotisar, Tehsil/Taluka – Thanesar, Town/City- Jyotisar, District- Kurukshetra-136119, State- Haryana for B.Ed. course of two years duration with an intake of 100 students.

AND, WHEREAS, the matter was placed before the NRC in its 218th meeting held from August 27th to 31st, 2013. The Committee decided as under:-

“The original file of the Institution and along with other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC in detail and following observations was made:-

- The online application was made on 27.12.2012 and the hard copy of the same is received on 31.01.2013. There is no proof that the application was dispatched within 7 days from the date of online application as required in NCTE Regulations, 2009.

Hence, NRC decided that Show Cause Notice under section 14/15 (3) (b) of NCTE Act, 1993 be issued to the Institution on the above point and direct the Institution to submit the reply as per the provisions of NCTE Act, 1993 Rules & Regulations within 30 days from the date of issue of Show Cause Notice.”

AND, WHEREAS, a show cause notice was issued on 08.10.2013 to the institution.

AND, WHEREAS, the institution did not submit reply of show cause notice dt. 08.10.2013.

AND, WHEREAS, the NRC in its 229th meeting held on 27th November, 2014, decided as under:

“The NRC considered the letter and decided to issue show cause notice to all such minority institutions whose applications for recognition of B.Ed. and D.El.Ed. courses are still under process.”

AND, WHEREAS, a show cause notice was issued on 07.01.2015 to the institution.

AND, WHEREAS, the matter was placed before the NRC in its 239th meeting held on 30th June & 01st July, 2015. The Committee decided as under:-

“The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations were carefully considered by NRC and following observation was made.


- The institution did not submit reply of SCN dt. 08.10.2013.

Hence, the Committee decided that recognition/permission to the institution is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution.”

NOW, THEREFORE, the Northern Regional Committee hereby refuses recognition under section 14/15(3)(b) of the NCTE Act.1993 to the institution i.e. **MA Durga Puran College of Education, Plot No.-84/5/2, 6/1, Street No.-428, Village- Josar(Jyotisar), Post Office- Jyotisar, Tehsil/Taluka – Thanesar, Town/City- Jyotisar, District- Kurukshetra-136119, State- Haryana** on the grounds mentioned above.


If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of the NCTE Act, 1993 in the “online mode” available on NCTE’s website www.ncte-india.org within 60 days from the date of this order. The guidelines for filing of appeal are available on NCTE website.
