REFUSAL ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Shri Mahaveer Educational & Charitable Trust, Plot / Khasra Number – Flat No. 9, Street Number- Agarwal Apartment Thapar Nagar, Village- Meerut, Post Office- Meerut, Tehsil/Taluka- Meerut, Town/City- Meerut, District – Meerut, State – Uttar Pradesh, Pin Code:- 250002 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for-seeking permission to the institution i.e. Mahaveer Girls College of Education, Plot / Khasra Number –37/1, 39 kha, 42, 44, 46, 47, 48, 49, Street Number-NA, Village- Kheddikala, Post Office- Harra, Tehsil/Taluka- Sardhana, Town/City- Meerut, District – Meerut, State – Uttar Pradesh, Pin Code :-250344 for B.Ed. Course of one year for an intake of 100 seats students on 30.12.2012.

AND WHEREAS, after scrutinizing the application of the institution, the application was found to be deficient and a Deficiency Letter dated 09.07.2013 was issued to the institution on the following points:-

- The institution has not submitted approved building plan in original. The original building plan approved by competent authority indicating name of institution, name of the course, Khasra No./Plot No. of land, total land area & built up area, size of multipurpose hall, class rooms, library, different resource centre etc as per NCTE norms for the proposed course is required to be submitted.

AND WHEREAS, the institution has submitted its reply received in the office of NRC on 16.09.2013. The matter was carefully considered by NRC in its 220th Meeting and as per decision of NRC, a VT was issued to the institution.

AND WHEREAS, The matter was carefully considered by NRC in its 221st Meeting and as per decision of NRC, a Show Cause Notice dated 22.01.2014 was issued to the institution on the following grounds:-

- The institution has submitted two application ID No. NRCAPP-6834 & NRCAPP-6957, the name and address of these institutions are same. As per provisions of clause 8(2) of NCTE Regulation, 2009, in the first instance an institution shall be considered to grant of recognition of only one course for a basic unit as prescribed in the norms and standards for the particular teacher programme. Therefore, more than one application submitted by the institution cannot be considered at the same time.


AND WHEREAS, the institution has not submitted its reply. The matter was carefully considered by NRC in its 237th Meeting held on May 11-13, 2015 and NRC refused the recognition on the following grounds:-

- Institution has not submitted reply to the show cause notice.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Mahaveer Girls College of Education, Plot / Khasra Number –37/1, 39 kha, 42, 44, 46, 47, 48, 49, Street Number-NA, Village- Kheddikala, Post Office- Harra, Tehsil/Taluka- Sardhana, Town/City- Meerut, District – Meerut, State – Uttar Pradesh, Pin Code :-250344 for the B.Ed. Course on the grounds mentioned above.


If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.
