REFUSAL ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, 1993 Sheikhul Hind Educational Charitable Trust, Plot No - 1, Street/Road - Bahadur Shah Zafar Marg, Village/Town/City - New Delhi, Post Office - IP Estate, Tehsil/Taluka - NA, Town/City - New Delhi, District - Central Delhi - 110002 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Silver Oak Women Teachers Training College, Plot / Khasra Number - 232/7, 232/9, 233, 238, 239, 240, Street Number - NA, Village - Rawali, Post Office - Masuri, Tehsil/Taluka - Hapur, Town/City- Shaikhpur Khichra, District- Ghaziabad, State - Uttar Pradesh, Pin Code - 201302 for D.El.Ed. Course of Two year's duration for an intake of 50 seats students on 28.09.2011.

AND WHEREAS, as per decision taken by NRC, Deficiency Letter dated 19.03.2012 was issued to institution. The matter was considered by the NRC in its 202nd Meeting and it was decided that that VT be constituted.

AND WHEREAS, the inspection of sad institution was conducted by the Visiting Team and the Report submitted by the Visiting Team was considered by the NRC in its 215th meeting and it was decided to refuse the application under clause 14/15 (3) (b) on NCTE Act, 1993 on the following grounds:-

- Institution refused to get it inspected when VT visited.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 2009, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e Silver Oak Women Teachers Training College, Plot / Khasra Number - 232/7, 232/9, 233, 238, 239, 240, Street Number - NA, Village - Rawali, Post Office - Masuri, Tehsil/Taluka- Hapur, Town/City- Shaikhpur Khichra, District- Ghaziabad, State - Uttar Pradesh, Pin Code - 201302 for the D.El.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.
