REFUSAL ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Janhit Institute of Education And Information, Plot Number- SH.-299, Street/Road- NA, Village/Town/City- Shastri Nagar, Post Office- Kavi Nagar, Tehsil/Taluka- Ghaziabad, Town/City- Ghaziabad, District- Ghaziabad(UP), State- UP, Pin Code- 201001 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Janhit Institute of Management Technology, Plot/Khasra Number- 55 B, Street Number- KP- 5th, Village- Knowledge Park- 5th, Post Office- Gr. Noida, Tehsil/Taluka- G. B. Nagar(Sadar), Town/City- Gr. Noida, District- Gautam Buddha Nagar(UP), State- Uttar Pradesh, Pin Code- 201306 for B.Ed. Course of one year for an intake of 100 seats students on 31.12.2012.

AND WHEREAS, As per decision of NRC taken in its 220th meeting, Show Cause Notice was issued to the institution on 28.05.2015 on the following grounds:

- The deficiencies were communicated to the institution by NRC, vide letter dated 18.07.2013 with the direction to submit the reply of deficiencies within 60 days from the date of deficiency letter. The institution has not submitted its reply to the office of NRC.

AND WHEREAS, The institution has not submitted its reply of the Show Cause Notice. The matter was considered by NRC in its 241st Meeting held on 03rd to 07th August, 2015 and it was decided that the application of the institution be refused on the following grounds:

- The institution did not submit reply of Show Cause Notice.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Janhit Institute of Management Technology, Plot/Khasra Number- 55 B, Street Number- KP- 5th, Village- Knowledge Park- 5th, Post Office- Gr. Noida, Tehsil/Taluka- G. B. Nagar(Sadar), Town/City- Gr. Noida, District- Gautam Buddha Nagar(UP), State- Uttar Pradesh, Pin Code- 201306 for the B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.org within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.
