REFUSAL ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, 1993, Sarvhit Charitable Trust, Plot no.- 666, Village – Chanderu, Post Office – Chanderu, Tehsil– Sikandrabad, Dist.– Bulandshahr, State– Uttar Pradesh– 203001.had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Sarvhitkari College of Education, Plot No.- 666, Village – Chanderu, Post Office – Chanderu, Tehsil– Sikandrabad, Dist.– Bulandshahr, State– Uttar Pradesh – 203001. for B.Ed. Course of Two Year duration for an intake of 100 seats students on 28.12.2012.

AND WHEREAS, a Show Cause Notice was issued to the institution on 08.01.2014 by the NRC and the institution did not submit its reply in response to the deficiency letter issued by the NRC. The matter was considered by the NRC in its 221<sup>st</sup> meeting the Committee decided that show cause notice be issued to the institution. Accordingly, a show cause notice dt. 08.01.2014 was issued to the institution by NRC on the following point:-

- Original FDRs of Rs. Five Lakh and Three Lakh of towards Endowment fund and Reserved Fund respectively have not submitted by the institution.
- Copy of change of land use certificate issued by the Competent Authority has been submitted by the institution is not notarized.

AND WHEREAS, the matter was considered by the NRC in its 240<sup>th</sup> meeting held from 20<sup>th</sup> to 22<sup>nd</sup> July, 2015 and the Committee decided that recognition to the institution is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution on the following point:-

- The institution has not submitted reply of SCN.

NOW THEREFORE, in exercise of the powers vested under section 14/15(3)(b) of NCTE Act, 2009. the Northern Regional Committee hereby refused the recognition of the institution i.e. Sarvhitkari College of Education, Plot No.- 666, Village – Chanderu, Post Office – Chanderu, Tehsil– Sikandrabad, Dist.– Bulandshahr, State– Uttar Pradesh – 203001. in the B.Ed. course on the grounds mentioned above.

If the institution is not satisfied by the above order they can prefer an appeal to the Council (NCTE, New Delhi) in terms of section 18 of NCTE Act, 1993 in the “online mode” available on NCTE’s website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the issue of this order.
