Refusal Order

WHEREAS, in terms of section 14/15(1) of the NCTE Act, 1993, Mukh Ram Memorial Education Society, Plot No.- 07, Village/Town/City- Durjanpur, Post Office- Durjanpur, Tehsil/Taluka- Hisar, Dist.- Hissar, State- Haryana- 125001 had submitted an application to the Northern Regional Committee of NCTE on 31.12.2012 for grant of recognition / permission to the institution i.e. Mukh Ram Memorial College of Education, Plot No.- 57(Khasara no.- 67/17), Village- Naloi, Post Office- Naloi, Tehsil/Taluka- Siwani Mandi, Dist.- Bhiwani, State- Haryana- 127046 for D.El.Ed. course of two years duration with an intake of 50 students.

AND, WHEREAS, a deficiency letter was issued on 13.08.2013 to the institution.

AND, WHEREAS, the reply dated 10.10.2013 from the institution in response to the deficiency letter was received on 10.10.2013 in NRC office. The matter was placed before the NRC in its 224<sup>th</sup> meeting held on 28<sup>th</sup> January to 02<sup>nd</sup> February, 2014. The Committee decided as under:-

"The original file of the Institution and alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC in detail and following observations were made:-

- Notarized copy of change of land use certificate under clause 143 of UP land Act issued by the competent authority has not been submitted.
- The original building plan approved by the competent authority indicating name of the institution, name of the course, khasra No./Plot No. of land, total land area & built up area, size of multipurpose hall, class rooms, library, different resource center etc as per the NCTE , norms for the proposed course has not been submitted.

Hence, NRC decided that Show Cause Notice under section 14/15 (3) (b) of NCTE Act, 1993 be issued to the Institution on the above point and direct the Institution to submit the reply as per the provisions of NCTE Act, 1993 Rules & Regulations within 30 days from the date of issue of Show Cause Notice."

Accordingly, a show cause notice was issued to the institution on 11.03.2014 to the institution.

AND, WHEREAS, the institution has not submit the reply of show cause notice dt. 11.03.2014. The matter was placed before the NRC in its 239<sup>th</sup> meeting held on 30<sup>th</sup> June & 01<sup>st</sup> July, 2015. The Committee decided as under:-

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations were carefully considered by NRC and following observation was made:

- The institution did not submit deficiency letter.

Hence, show cause notice under Section 14/15 (3)(b) of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice."

AND, WHEREAS, while confirming the minutes of 239<sup>th</sup> meeting in 240<sup>th</sup> meeting held on 20-22 July, 2015. The Committee decided as under:-


"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations were carefully considered by NRC and following observation was made:

- The institution has not submitted reply of SCN.

Hence, the Committee decided that recognition/permission to the institution is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution."

NOW, THEREFORE, the Northern Regional Committee hereby refuses recognition under section 14/15(3)(b) of the NCTE Act.1993 to the institution i.e. **Mukh Ram Memorial College of Education, Plot No.- 57(Khasara no.- 67/17), Village- Naloi, Post Office- Naloi, Tehsil/Taluka- Siwani Mandi, Dist.- Bhiwani, State- Haryana- 127046** on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of the NCTE Act. 1993 in the "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of this order. The guidelines for filing of appeal are available on NCTE website.
