REFUSAL ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Lord Shiva Educational Society, Plot Number- 171, Street/Road- Barsana Road, Village/Town/City- Barsana, Post Office- Barsana, Tehsil/Taluka- Chhata, Town/City- Barsana, District- Mathura (UP), State- UP, Pin Code- 241405 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Lord Shiva College of Education, Plot Number- 553, 171, Street/Road- Barsana R, Village/Town/City- Barsana, Post Office- Barsana, Tehsil/Taluka- Chhata, Town/City- Barsana, District- Mathura (UP), State- UP, Pin Code- 241405 for B.Ed. Course of one year for an intake of 100 seats students on 31.12.2012.

AND WHEREAS, The inspection of the institution was not conducted. The VTR was considered by NRC in its 235<sup>th</sup> Meeting and as per decision of NRC, a Show Cause Notice dated 29.04.2015 was issued to the institution on the following grounds:

- The institution refused for inspection.


AND WHEREAS, The institution has not submitted its reply of the Show Cause Notice. The matter was considered by NRC in its 239<sup>th</sup> Meeting held on 30<sup>th</sup> June to 01<sup>st</sup> July, 2015 and it was decided that the application of the institution be refused on the following grounds:

- No reply of the SCN issued by NRC NCTE dated 29.04.2015 has been submitted by the institution. Hence, rejected.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Lord Shiva College of Education, Plot Number- 553, 171, Street/Road- Barsana R, Village/Town/City- Barsana, Post Office- Barsana, Tehsil/Taluka- Chhata, Town/City- Barsana, District- Mathura (UP), State- UP, Pin Code- 241405 for the B.Ed. Course on the grounds mentioned above.

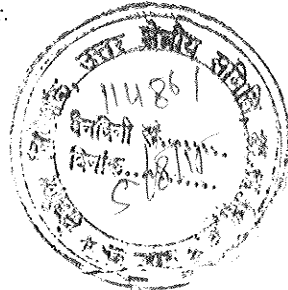
