Refusal Order

WHEREAS, in terms of section 14/15(1) of the NCTE Act, 1993, Radha Swami Education And Medical Science Development Society , 1906/1 , Shastri Nagar Hissar Road , Rohtak , Rohtak , Rohtak , Rohtak , Haryana , 124001, had submitted an application to the Northern Regional Committee of NCTE on 31.12.2012 for grant of recognition / permission to the institution i.e. Radha Swami College Of Education , 44/14, 15, 45/11, 9/2, 107/20 , Education , 44/14 , 2 , Kharkara , Kharkara , Meham , Rohtak , 124111 for B.Ed. course of two years duration with an intake of 100 students.

AND, WHEREAS, the matter was placed before the NRC in its 219th meeting held from September 27th to 29th , 2013. The Committee decided as under:-

“The original file of the Institution and along with other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC in detail and following observations was made:-

- The institution has submitted lease deed executed between Surendra – Raj Kumar S/o Shri Dilbaag, Sakinan Kheda, Rohtak and Radha Swami Education and Medical Science Development Society, Rohtak for a period of 99 years. Thus the institution does not possess land on the date of application.

Hence, NRC decided that Show Cause Notice before summarily rejection on the above point and direct the Institution to submit the reply as per the provisions of NCTE Act, 1993 Rules & Regulations within 30 days from the date of issue of Show Cause Notice.”

Accordingly, a show cause notice was issued on 18.10.2013 to the institution.

AND, WHEREAS, the institution did not submit reply of show cause notice dt. 18.10.2013 . The matter was placed before the NRC in its 239th meeting held on 30th June & 01st July, 2015. The Committee decided as under:-

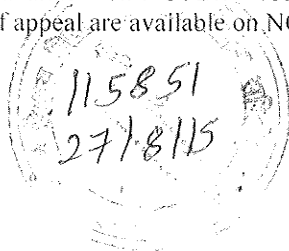
“The original file of the Institution alongwith other related documents, NCTE Act. 1993, Regulations were carefully considered by NRC and following observation was made.

- The institution did not submit reply of SCN.

Hence, the Committee decided that recognition/permission to the institution is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution.”

NOW, THEREFORE, the Northern Regional Committee hereby refuses recognition under section 14/15(3)(b) of the NCTE Act.1993 to the institution i.e. Radha Swami College Of Education , 44/14, 15, 45/11, 9/2, 107/20 , Education , 44/14 , 2 , Kharkara , Kharkara , Meham , Rohtak , 124111 on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of the NCTE Act. 1993 in the “online mode” available on NCTE’s website www.ncte-india.org within 60 days from the date of this order. The guidelines for filing of appeal are available on NCTE website.


