REFUSAL ORDER

Date: 14 AUG 2015

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Sankat Mochan Laghu Madhyamik Vidyalay Samiti, Plot Number- 0, Street/Road- 0, Village/Town/City- Gaura, Post Office- Gaura Katari, Tehsil/Taluka- Gauriganj, Town/City- Amethi, District- Sultanpur(UP), State- UP, Pin Code- 227801 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Shri Brij Mohan Singh Shikshan Prashikshan Sansthan, Plot/Khasra Number- 177, Street Number- 0, Village- Purab Gaura, Post Office- Gaura, Tehsil/Taluka- Gauriganj, Town/City- Amethi, District- Sultanpur(UP), State- Uttar Pradesh, Pin Code- 227801 for B.Ed. Course of one year for an intake of 100 seats students on 30.12.2012.

AND WHEREAS, The reply of the Show Cause Notice submitted by the institution was considered by the NRC in its 223rd Meeting and it was decided by NRC that file be processed further and deficiency letter may be issued to the institution:-

- As per land documents submitted by the institution the plot Khasara 177 has only .101 Hect. Land which is less than required area. However the institution has also submitted some other land document Khata & Khasara No. 156, 162, & 163 but these Khasara are not mention in the application form.
- Notarized copy of change of land use certificate issued under clause 143 of UP land Act by the competent authority has not submitted.
The institution has submitted an affidavit of Rs. 100/- where is sr. no. 5 is not filled up properly.
The specific information of land/building, demarcated area as per the NCTE Regulations, 2014 and information related to resolution of the society for opening the said course not for profit etc. has not given by the institution, hence, the same is required from the institution in the affidavit (format of the affidavit is enclosed herewith).

AND WHEREAS, As per decision of NRC taken in its 236th Meeting, Show Cause Notice was issued to the institution on 14.05.2015 on the following grounds:-

The institution has not submitted reply of the deficiency letter dt. 03.03.2014.

AND WHEREAS, the institution has not submitted its reply. The matter was carefully considered by NRC in its 241st Meeting held on 03rd to 07th August, 2015 and NRC refused the recognition on the following grounds:-

- The institution did not submit reply of Show Cause Notice.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Shri Brij Mohan Singh Shikshan Prashikshan Sansthan, Plot/Khasra Number- 177, Street Number- 0, Village- Purab Gaura, Post Office- Gaura, Tehsil/Taluka- Gauriganj, Town/City- Amethi, District- Sultanpur(UP), State- Uttar Pradesh, Pin Code- 227801 for the B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.
