REFUSAL ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Rainbow Public School Shiksha Samiti, Plot Number -129, Street /Road- NH-2, Village/Town/City- Umran, Post Office- Bara, Tehsil/Taluka- Akbarpur, Town/City- Raniya, District- Kanpur Dehat, State- Uttar Pradesh, Pin Code- 209311 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Ram Janki College of Education, Plot / Khasra Number- 129, Street Number- NH 2 Rania, Village- Umran, Post Office- Bara, Tehsil/Taluka- Akbarpur, Town/City- Raniya, District- Kanpur Dehat, State- Uttar Pradesh, Pin Code- 209311 for B.Ed. Course of one year for an intake of 100 seats students on 30.12.2012.

AND WHEREAS, As per decision of NRC taken in its 236th meeting, Show Cause Notice was issued to the institution on 18.05.2015 on the following grounds:

AND WHEREAS, The institution has not submitted its reply of the Show Cause Notice. The matter was considered by NRC in its 241st Meeting held on 03rd to 07th August, 2015 and it was decided that the application of the institution be refused on the following grounds:

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Ram Janki College of Education, Plot / Khasra Number- 129, Street Number- NH 2 Rania, Village- Umran, Post Office- Bara, Tehsil/Taluka- Akbarpur, Town/City- Raniya, District- Kanpur Dehat, State- Uttar Pradesh, Pin Code- 209311 for the B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.

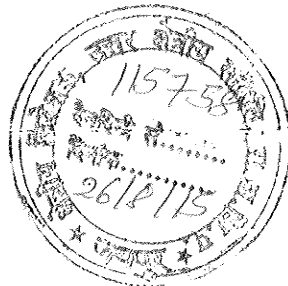
