Refusal Order

WHEREAS, in terms of section 14/15(1) of the NCTE Act, 1993, Puran Educational Society Plot No-84/5/2,6/, Street/ Road-Pehowa Road, Vill- Josar(Jyotisar), Post Office- Jyotisar, Teh/Taluk- Thanesar, Town/City- Jyotisar, Dist- Kurukshetra (HR), State-HR, Pin 136119, had submitted an application to the Northern Regional Committee of NCTE on 31.12.2012 for grant of recognition / permission to the institution i.e. Maa Durga Puran College of Education, Plot/Khasara No-5(7-2),6(6-12), Plot No. 84/5/2,6/, Street Number-428 , Vill- Josar(Jyotisar), Post Office- Jyotisar, Teh/Taluk- Thanesar, Town/City- Jyotisar, Dist- Kurukshetra (HR), State-HR, Pin 136119 for M.Ed. course of two years duration with an intake of 50 students.

AND, WHEREAS, the matter was placed before the NRC in its 219th meeting held from **September 26th to 29th, 2013**. The Committee decided as under:-

“The original file of the Institution and along with other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC in detail and following observations was made:-

- Institution is not conducting B.Ed Course. Hence not applicable for process of M. Ed Course.

Hence, NRC decided that Show Cause Notice before summarily rejection on the above point and direct the Institution to submit the reply as per the provisions of NCTE Act, 1993 Rules & Regulations within 30 days from the date of issue of Show Cause Notice.”

AND, WHEREAS, a show cause notice was issued on **18.10.2013** to the institution.

AND, WHEREAS, the institution did not submit reply of show cause notice dt. **18.10.2013**.

AND, WHEREAS, the NRC in its 229th meeting held on 27th November, 2014, decided as under:

“The NRC considered the letter and decided that the negative recommendations be treated as general recommendation for all such other applications received for M.Ed. course for the academic session 2013-14.”

AND, WHEREAS, a show cause notice was issued on **07.01.2015** to the institution.


AND, WHEREAS, the matter was placed before the NRC in its 239th meeting held on **30th June & 01st July, 2015**. The Committee decided as under:-

“The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations were carefully considered by NRC and following observation was made.

- Non receipt of reply of SCN dated 18.10.2013.

Hence, the Committee decided that recognition/permission to the institution is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution.”


NOW, THEREFORE, the Northern Regional Committee hereby refuses recognition/permission under section 14/15(3)(b) of the NCTE Act, 1993 to the institution i.e. Maa Durga Puran College of Education Plot/Khasara No-5(7-2),6(6-12), Plot No. 84/5/2,6/, Street Number-428 , Vill- Josar(Jyotisar), Post



Office- Jyotisar, Teh/Taluk- Thanesar, Town/City- Jyotisar, Dist- Kurukshetra (HR), State-HR, Pin 136119 on the grounds mentioned above.
